AND NOW, THIS 25TH DAY OF JULY, 2013, THE SECRETARY OF THE COMMONWEALTH, HAVING FOUND THAT **JUST DONATED, INC.**, 622 WEST ANGUS AVENUE, ORANGE, CA 92868, IS NOT REGISTERED WITH THE DEPARTMENT'S BUREAU OF CHARITABLE ORGANIZATIONS AND HAS PROVIDED PROFESSIONAL SOLICITOR AND OR PROFESSIONAL COUNSEL SERVICES TO A CHARITABLE ORGANIZATION SOLICITING CONTRIBUTIONS IN PENNSYLVANIA WHILE IT WAS NOT REGISTERED AND IN ABSENCE OF AN APPROVED CONTRACT; IN ACCORDANCE WITH THE PENNSYLVANIA SOLICITATION OF FUNDS FOR CHARITABLE PURPOSES ACT, 10 P.S. § 162.1, *ET SEQ.*, HEREBY ORDERS **JUST DONATED, INC.**, TO CEASE AND DESIST FROM PROVIDING PROFESSIONAL SOLICITOR AND OR PROFESSIONAL COUNSEL SERVICES IN PENNSYLVANIA UNTIL SUCH TIME AS **JUST DONATED, INC.** DULY REGISTERS OR PROVIDES INFORMATION THAT IT IS EXCLUDED OR EXEMPT FROM REGISTRATION. ADDITIONALLY, **JUST DONATED, INC.** MAY BE SUBJECT TO ADMINISTRATIVE FINES OF UP TO \$1,000 PER VIOLATION AND \$100 FOR EACH DAY THE VIOLATION CONTINUES. THIS ORDER SHALL TAKE EFFECT IMMEDIATELY.
