ORDER

AND NOW, THIS 23RD DAY OF AUGUST 2012, THE SECRETARY OF THE COMMONWEALTH, HAVING FOUND THAT HUNTING 4 HOPE, DONALD MILLER, AND ASHLEY HUNTING, 95 AMPLE AVE., TUNKHANNOK, PA 18657, ARE NOT REGISTERED WITH THE DEPARTMENT'S BUREAU OF CHARITABLE ORGANIZATIONS, HAVE FAILED TO RESPOND TO THE BUREAU'S REQUEST FOR INFORMATION AND HAVE SOLICITED CONTRIBUTIONS IN PENNSYLVANIA WHILE IT NOT REGISTERED; IN ACCORDANCE WITH THE PENNSYLVANIA SOLICITATION OF FUNDS FOR CHARITABLE PURPOSES ACT, 10 P.S. § 162.1 *ET SEQ.*, HEREBY ORDERS HUNTING 4 HOPE, DONALD MILLER, AND ASHLEY HUNTING TO CEASE AND DESIST FROM SOLICITING CONTRIBUTIONS IN PENNSYLVANIA UNTIL SUCH TIME AS HUNTING 4 HOPE, DONALD MILLER, AND ASHLEY HUNTING HAS DULY REGISTERED WITH THE BUREAU OR PROVIDED INFORMATION THAT IT IS EXCLUDED OR EXEMPT FROM REGISTRATION. THIS ORDER SHALL TAKE EFFECT IMMEDIATELY. ADDITIONALLY, HUNTING 4 HOPE, DONALD MILLER, AND ASHLEY HUNTING MAY BE SUBJECT TO ADMINISTRATIVE FINES OF UP TO \$1,000 PER VIOLATION AND \$100 FOR EACH DAY THE VIOLATION CONTINUES. THIS ORDER SHALL TAKE EFFECT IMMEDIATELY.
