IN THE MATTER OF: O&P RESCUE

ORDER

AND NOW, THIS 12TH DAY OF SEPTEMBER 2013, THE SECRETARY OF THE COMMONWEALTH, HAVING FOUND THAT O&P RESCUE, WILLIAM URA AND RANDY KOVACH, JR., 3010 CRONEMEYER STREET, MCKEESPORT, PA 15132, ARE NOT REGISTERED WITH THE DEPARTMENT'S BUREAU OF CHARITABLE ORGANIZATIONS, HAVE FAILED TO RESPOND TO THE BUREAU'S INVESTIGATIVE SUBPOENA AND HAVE SOLICITED CONTRIBUTIONS IN PENNSYLVANIA WHILE IT WAS NOT REGISTERED; IN ACCORDANCE WITH THE PENNSYLVANIA SOLICITATION OF FUNDS FOR CHARITABLE PURPOSES ACT, 10 P.S. § 162.1 *ET SEQ.*, HEREBY ORDERS O&P RESCUE, WILLIAM URA AND RANDY KOVACH, JR., TO CEASE AND DESIST FROM SOLICITING CONTRIBUTIONS IN PENNSYLVANIA UNTIL SUCH TIME AS O&P RESCUE, WILLIAM URA AND RANDY KOVACH, JR., HAVE PROVIDED ALL SUBPOENED DOCUMENTS, HAVE DULY REGISTERED WITH THE BUREAU OR PROVIDED INFORMATION THAT IT IS EXCLUDED OR EXEMPT FROM REGISTRATION. THIS ORDER SHALL TAKE EFFECT IMMEDIATELY. ADDITIONALLY, O&P RESCUE, WILLIAM URA AND RANDY KOVACH, JR., MAY BE SUBJECT TO ADMINISTRATIVE FINES OF UP TO \$1,000 PER VIOLATION AND \$100 FOR EACH DAY THE VIOLATION CONTINUES. THIS ORDER SHALL TAKE EFFECT IMMEDIATELY.
