AND COLUMBUS RESTORATION CHURCH

ORDER

AND NOW, THIS 12TH DAY OF SEPTEMBER 2013, THE SECRETARY OF THE COMMONWEALTH, HAVING FOUND THAT UNITED RESTORATION MINISTRIES, COLUMBUS RESTORATION MINISTRIES AND COLUMBUS RESTORATION CHURCH, ARE NOT REGISTERED WITH THE DEPARTMENT'S BUREAU OF CHARITABLE ORGANIZATIONS, HAVE FAILED TO RESPOND TO THE BUREAU'S REQUEST FOR REGISTRATION REQUIREMENTS AND HAVE SOLICITED CONTRIBUTIONS IN PENNSYLVANIA WHILE IT WAS NOT REGISTERED; IN ACCORDANCE WITH THE PENNSYLVANIA SOLICITATION OF FUNDS FOR CHARITABLE PURPOSES ACT, 10 P.S. § 162.1 *ET SEQ.*, HEREBY ORDERS UNITED RESTORATION MINISTRIES, COLUMBUS RESTORATION MINISTRIES AND COLUMBUS RESTORATION CHURCH, TO CEASE AND DESIST FROM SOLICITING CONTRIBUTIONS IN PENNSYLVANIA UNTIL SUCH TIME AS UNITED RESTORATION MINISTRIES, COLUMBUS RESTORATION MINISTRIES AND COLUMBUS RESTORATION CHURCH HAVE DULY REGISTERED WITH THE BUREAU OR PROVIDED INFORMATION THAT IT IS EXCLUDED OR EXEMPT FROM REGISTRATION. THIS ORDER SHALL TAKE EFFECT IMMEDIATELY. ADDITIONALLY, UNITED RESTORATION MINISTRIES, COLUMBUS RESTORATION MINISTRIES AND COLUMBUS RESTORATION CHURCH, MAY BE SUBJECT TO ADMINISTRATIVE FINES OF UP TO \$1,000 PER VIOLATION AND \$100 FOR EACH DAY THE VIOLATION CONTINUES. THIS ORDER SHALL TAKE EFFECT IMMEDIATELY.
