ORDER

AND NOW, THIS 25<sup>TH</sup> DAY OF SETEMBER, 2012, THE SECRETARY OF THE COMMONWEALTH HAVING FOUND THAT CHIEFS THUNDER AND LEN BOYCE, 1402 EDDY COURT, GIBSONIA, PA 15044, IS NOT REGISTERED WITH THE DEPARTMENT'S BUREAU OF CHARITABLE ORGANIZATIONS, AND HAS REFUSED TO COMPLY WITH THE PENNSYLVANIA OFFICE OF ATTORNEY GENERAL'S REPEATED REQUESTS FOR INFORMATION; IN ACCORDANCE WITH THE PENNSYLVANIA SOLICITATION OF FUNDS FOR CHARITABLE PURPOSES ACT, 10 P.S. § 162.1 *ET SEQ.*, HEREBY ORDERS CHIEFS THUNDER AND LEN BOYCE TO CEASE AND DESIST FROM SOLICITING CONTRIBUTIONS IN PENNSYLVANIA UNTIL SUCH TIME AS CHIEFS THUNDER AND LEN BOYCE PROPERLY REGISTERS WITH THE BUREAU AND COMPLIES WITH THE OFFICE OF ATTORNEY GENERAL'S REQUESTS FOR INFORMATION. ADDITIONALLY, CHIEFS THUNDER AND LEN BOYCE MAY BE SUBJECT TO ADMINISTRATIVE FINES OF UP TO \$1,000 PER VIOLATION AND \$100 FOR EACH DAY THE VIOLATION CONTINUES. THIS ORDER SHALL TAKE EFFECT IMMEDIATELY.
