IN THE MATTER OF: BROTHERHOOD OF CHRISTIANITY AND TROY LEITNER

ORDER

AND NOW, THIS 11TH DAY OF OCTOBER, 2012, THE SECRETARY OF THE COMMONWEALTH, HAVING FOUND THAT BROTHERHOOD OF CHRISTIANITY AND TROY LEITNER, 1151 LUZERNE STREET, SCRANTON, PA 18504, ARE NOT REGISTERED WITH THE DEPARTMENT'S BUREAU OF CHARITABLE ORGANIZATIONS, THAT BROTHERHOOD OF CHRISTIANITY AND TROY LEITNER HAVE FAILED TO KEEP TRUE FISCAL RECORDS, FAILED TO DEPOSIT CONTRIBUTIONS IN AN ACCOUNT IN THE NAME OF BROTHERHOOD OF CHRISTIANITY AND UNDER ITS SOLE CONTROL, AND HAVE SOLICITED CONTRIBUTIONS IN PENNSYLVANIA WHILE BROTHERHOOD OF CHRISTIANITY WAS NOT REGISTERED; IN ACCORDANCE WITH THE PENNSYLVANIA SOLICITATION OF FUNDS FOR CHARITABLE PURPOSES ACT, 10 P.S. § 162.1, ET SEO., HEREBY ORDERS BROTHERHOOD OF CHRISTIANITY AND TROY LEITNER TO CEASE AND DESIST FROM SOLICITING CONTRIBUTIONS IN PENNSYLVANIA UNTIL SUCH TIME AS BROTHERHOOD OF CHRISTIANITY AND TROY LEITNER COME INTO COMPLIANCE WITH ALL PROVISIONS OF THE ACT AND BROTHERHOOD OF CHRISTIANITY DULY REGISTERS OR PROVIDES INFORMATION THAT IT IS EXCLUDED OR EXEMPT FROM REGISTRATION. ADDITIONALLY, BROTHERHOOD OF CHRISTIANITY AND TROY LEITNER MAY BE SUBJECT TO ADMINISTRATIVE FINES OF UP TO \$1,000 PER VIOLATION AND \$100 FOR EACH DAY THE VIOLATION CONTINUES. THIS ORDER SHALL TAKE EFFECT IMMEDIATELY.
