CEASE AND DESIST ORDER

AND NOW, THIS 20<sup>TH</sup> DAY OF APRIL, THE SECRETARY OF THE COMMONWEALTH, HAVING FOUND THAT FIBROMUSCULAR DYSPLASIA SOCIETY OF AMERICA, INC, 20325 CENTER RIDGE ROAD, SUITE 360, ROCKY RIVER, OHIO 44116, IS NOT REGISTERED WITH THE DEPARTMENT'S BUREAU OF CORPORATIONS AND CHARITABLE ORGANIZATIONS, THAT FIBROMUSCULAR DYSPLASIA SOCIETY OF AMERICA, INC HAS FAILED TO PROVIDE THE BUREAU WITH ALL REQUESTED INFORMATION, AND HAS SOLICITED CONTRIBUTIONS IN PENNSYLVANIA WHILE IT WAS NOT REGISTERED; IN ACCORDANCE WITH THE PENNSYLVANIA SOLICITATION OF FUNDS FOR CHARITABLE PURPOSES ACT, 10 P.S. § 162.1, *ET SEQ.*, HEREBY ORDERS FIBROMUSCULAR DYSPLASIA SOCIETY OF AMERICA, INC TO CEASE AND DESIST FROM SOLICITING CONTRIBUTIONS IN PENNSYLVANIA UNTIL SUCH TIME AS FIBROMUSCULAR DYSPLASIA SOCIETY OF AMERICA, INC PROVIDES THE BUREAU WITH ALL PREVIOUSLY REQUESTED INFORMATION AND FIBROMUSCULAR DYSPLASIA SOCIETY OF AMERICA, INC DULY REGISTERS OR PROVIDES INFORMATION THAT IT IS EXCLUDED OR EXEMPT FROM REGISTRATION. ADDITIONALLY, FIBROMUSCULAR DYSPLASIA SOCIETY OF AMERICA, INC MAY BE SUBJECT TO ADMINISTRATIVE FINES OF UP TO \$1,000.00 PER VIOLATION AND \$100.00 FOR EACH DAY THE VIOLATION CONTINUES.

THIS ORDER SHALL TAKE EFFECT IMMEDIATELY.
