AMENDED CEASE AND DESIST ORDER

AND NOW, THIS 23rd DAY OF MARCH, 2017, THE SECRETARY OF THE COMMONWEALTH, HAVING FOUND THAT **KLYMAXXX ANGEL FUND**, 52 PLEASANT VIEW DRIVE, MECHANICSBURG, PENNSYLVANIA, 17050 AND 450 HILL TOP ROAD, YORK SPRINGS, PENNSYLVANIA, 17372, IS NOT REGISTERED WITH THE DEPARTMENT OF STATE'S BUREAU OF CORPORATIONS AND CHARITABLE ORGANIZATIONS, AND THAT **KLYMAXXX ANGEL FUND** HAS:

- 1) FAILED TO SUBMIT REQUESTED DOCUMENTATION TO THE BUREAU,
- 2) SOLICITED CONTRIBUTIONS IN THE COMMONWEALTH OF PENNSYLVANIA WHILE NOT REGISTERED,
- 3) FAILED TO MAINTAIN RECORDS AS REQUIRED BY SECTION 12, AND
- 4) FAILED TO DEPOSIT FUNDS AS REQUIRED BY SECTION 6(S);

IN ACCORDANCE WITH THE PENNSYLVANIA SOLICITATION OF FUNDS FOR CHARITABLE PURPOSES ACT, 10 P.S. § 162.1 *ET SEQ.*, **HEREBY ORDERS KLYMAXXX ANGEL FUND TO CEASE AND DESIST** FROM SOLICITING CONTRIBUTIONS IN PENNSYLVANIA UNTIL SUCH TIME AS IT PROVIDES THE BUREAU WITH ALL PREVIOUSLY REQUESTED INFORMATION AND DULY REGISTERS OR PROVIDES INFORMATION THAT IT IS EXCLUDED OR EXEMPT FROM REGISTRATION.

KLYMAXXX ANGEL FUND MAY ALSO BE SUBJECT TO FORMAL ADMINISTRATIVE ACTION, WHICH COULD RESULT IN THE IMPOSITION OF ADMINISTRATIVE FINES OF UP TO ONE THOUSAND DOLLARS (\$1,000) PER VIOLATION OF THE ACT PLUS AN ADDITIONAL PENALTY OF ONE HUNDRED DOLLARS (\$100) PER DAY FOR EACH DAY THE VIOLATION CONTINUES.

THIS ORDER SHALL TAKE EFFECT IMMEDIATELY.
