AND NOW, THIS 12TH DAY OF AUGUST 2011, THE SECRETARY OF THE COMMONWEALTH, HAVING FOUND THAT MARK & SELL SOLUTIONS, 1506 17TH AVENUE, SUITE 2, MOLINE, IL 61265, IS NOT REGISTERED WITH THE DEPARTMENT'S BUREAU OF CHARITABLE ORGANIZATIONS AND HAS PROVIDED PROFESSIONAL SOLICITOR AND OR PROFESSIONAL COUNSEL SERVICES TO A CHARITABLE ORGANIZATION SOLICITING CONTRIBUTIONS IN PENNSYLVANIA WHILE IT WAS NOT REGISTERED AND IN ABSENCE OF AN APPROVED CONTRACT; IN ACCORDANCE WITH THE PENNSYLVANIA SOLICITATION OF FUNDS FOR CHARITABLE PURPOSES ACT, 10 P.S. § 162.1, *ET SEQ.*, HEREBY ORDERS MARK & SELL SOLUTIONS TO CEASE AND DESIST FROM PROVIDING PROFESSIONAL SOLICITOR AND OR PROFESSIONAL COUNSEL SERVICES IN PENNSYLVANIA UNTIL SUCH TIME AS MARK & SELL SOLUTIONS DULY REGISTERS OR PROVIDES INFORMATION THAT IT IS EXCLUDED OR EXEMPT FROM REGISTRATION. ADDITIONALLY, MARK & SELL SOLUTIONS MAY BE SUBJECT TO ADMINISTRATIVE FINES OF UP TO \$1,000 PER VIOLATION AND \$100 FOR EACH DAY THE VIOLATION CONTINUES. THIS ORDER SHALL TAKE EFFECT IMMEDIATELY.
