CEASE AND DESIST ORDER

AND NOW, THIS 16th DAY OF MARCH, 2017, THE SECRETARY OF THE COMMONWEALTH, HAVING FOUND THAT MILITARY WITH PTSD, INC., JUSTIN GOURLEY AND SHAWN GOURLEY, 5900 TWICKINGHAM DRIVE, EVANSVILLE, INDIANA 47711, IS NOT REGISTERED WITH THE DEPARTMENT OF STATE'S BUREAU OF CORPORATIONS AND CHARITABLE ORGANIZATIONS AND HAS FAILED TO SUBMIT REQUESTED DOCUMENTATION TO THE PENNSYLVANIA OFFICE OF ATTORNEY GENERAL; IN ACCORDANCE WITH THE PENNSYLVANIA SOLICITATION OF FUNDS FOR CHARITABLE PURPOSES ACT, 10 P.S. § 162.1 *ET SEQ.*, **HEREBY ORDERS** MILITARY WITH PTSD, INC., JUSTIN GOURLEY AND SHAWN GOURLEY TO **CEASE AND DESIST** FROM SOLICITING CONTRIBUTIONS IN PENNSYLVANIA UNTIL SUCH TIME AS IT PROVIDES THE PENNSYLVANIA OFFICE OF ATTORNEY GENERAL WITH ALL PREVIOUSLY REQUESTED INFORMATION AND DULY REGISTERS OR PROVIDES INFORMATION THAT IT IS EXCLUDED OR EXEMPT FROM REGISTRATION.

RESPONDENT MAY ALSO BE SUBJECT TO FORMAL ADMINISTRATIVE ACTION, WHICH COULD RESULT IN THE IMPOSITION OF ADMINISTRATIVE FINES OF UP TO ONE THOUSAND DOLLARS (\$1,000.00) PER VIOLATION OF THE ACT PLUS AN ADDITIONAL PENALTY OF ONE HUNDRED DOLLARS (\$100.00) PER DAY FOR EACH DAY THE VIOLATION CONTINUES.

THIS ORDER SHALL TAKE EFFECT IMMEDIATELY.
