ORDER

AND NOW, THIS **28TH DAY OF AUGUST**, THE SECRETARY OF THE COMMONWEALTH, HAVING FOUND THAT **NJ CLIPPER CORPORATION**, 507 20 STREET, APT 6, UNION CITY, NJ 07087, IS NOT CURRENTLY REGISTERED AS A PROFESSIONAL SOLICITOR OR PROFESSIONAL FUNDRAISING COUNSEL AND HAS FAILED TO PROVIDE PROOF TO THE BUREAU REGARDING THE PROFESSIONAL SERVICES IT PROVIDES FOR CHARITABLE ORGANIZATIONS SOLICITING CONTRIBUTIONS IN PENNSYLVANIA; IN ACCORDANCE WITH THE PENNSYLVANIA SOLICITATION OF FUNDS FOR CHARITABLE PURPOSES ACT, 10 P.S. § 162.1 *ET SEQ.*, HEREBY ORDERS **NJ CLIPPER CORPORATION** TO CEASE AND DESIST FROM PROVIDING PROFESSIONAL SERVICES FOR CHARITABLE ORGANIZATIONS SOLICITING CONTRIBUTIONS IN PENNSYLVANIA UNTIL SUCH TIME AS **NJ CLIPPER CORPORATION** HAS DULY REGISTERED WITH THE BUREAU AND OBTAINS APPROVAL FOR ALL IT'S CONTRACTS WITH ORGANIZATIONS SOLICITING IN PENNSYLVANIA OR PROVIDED INFORMATION THAT IT IS EXCLUDED OR EXEMPT FROM REGISTRATION. ADDITIONALLY, **NJ CLIPPER CORPORATION** MAY BE SUBJECT TO ADMINISTRATIVE FINES OF UP TO \$1,000 PER VIOLATION AND \$100 FOR EACH DAY THE VIOLATION CONTINUES. THIS ORDER SHALL TAKE EFFECT IMMEDIATELY
