CEASE AND DESIST ORDER

AND NOW, THIS 16th DAY OF FEBRUARY, 2017, THE SECRETARY OF THE COMMONWEALTH, HAVING FOUND THAT NATIONAL CLUB ASSOCIATION FOUNDATION, 1201 15TH STREET, NW, SUITE 450, WASHINGTON, DC, 20005, IS NOT REGISTERED WITH THE DEPARTMENT OF STATE'S BUREAU OF CORPORATIONS AND CHARITABLE ORGANIZATIONS, AND THAT NATIONAL CLUB ASSOCIATION FOUNDATION HAS:

- 1) FAILED TO SUBMIT REQUESTED DOCUMENTATION TO THE BUREAU, AND
- 2) SOLICITED CONTRIBUTIONS IN THE COMMONWEALTH OF PENNSYLVANIA WHILE NOT REGISTERED;

IN ACCORDANCE WITH THE PENNSYLVANIA SOLICITATION OF FUNDS FOR CHARITABLE PURPOSES ACT, 10 P.S. § 162.1 *ET SEQ.*, *HEREBY ORDERS* NATIONAL CLUB ASSOCIATION FOUNDATION TO CEASE AND DESIST FROM SOLICITING CONTRIBUTIONS IN PENNSYLVANIA UNTIL SUCH TIME AS IT PROVIDES THE BUREAU WITH ALL PREVIOUSLY REQUESTED INFORMATION AND DULY REGISTERS OR PROVIDES INFORMATION THAT IT IS EXCLUDED OR EXEMPT FROM REGISTRATION.

NATIONAL CLUB ASSOCIATION FOUNDATION MAY ALSO BE SUBJECT TO FORMAL ADMINISTRATIVE ACTION, WHICH COULD RESULT IN THE IMPOSITION OF ADMINISTRATIVE FINES OF UP TO ONE THOUSAND DOLLARS (\$1,000) PER VIOLATION OF THE ACT PLUS AN ADDITIONAL PENALTY OF ONE HUNDRED DOLLARS (\$100) PER DAY FOR EACH DAY THE VIOLATION CONTINUES.

THIS ORDER SHALL TAKE EFFECT IMMEDIATELY.
