ORDER

AND NOW, THIS 15TH DAY OF JUNE, 2011, THE SECRETARY OF THE COMMONWEALTH, HAVING FOUND THAT NORTHEAST COMMITTEE ON HOMELESSNESS, 4442 FRANKFORD AVENUE, PHILADELPHIA, PA 19124, IS NOT REGISTERED WITH THE DEPARTMENT'S BUREAU OF CHARITABLE ORGANIZATIONS, THAT NORTHEAST COMMITTEE ON HOMELESSNESS HAS FAILED TO PROVIDE THE BUREAU WITH ALL REQUESTED INFORMATION, AND HAS SOLICITED CONTRIBUTIONS IN PENNSYLVANIA WHILE IT WAS NOT REGISTERED; IN ACCORDANCE WITH THE PENNSYLVANIA SOLICITATION OF FUNDS FOR CHARITABLE PURPOSES ACT, 10 P.S. § 162.1, *ET SEQ.*, HEREBY ORDERS NORTHEAST COMMITTEE ON HOMELESSNESS TO CEASE AND DESIST FROM SOLICITING CONTRIBUTIONS IN PENNSYLVANIA UNTIL SUCH TIME AS NORTHEAST COMMITTEE ON HOMELESSNESS PROVIDES THE BUREAU WITH ALL PREVIOUSLY REQUESTED INFORMATION AND NORTHEAST COMMITTEE ON HOMELESSNESS DULY REGISTERS OR PROVIDES INFORMATION THAT IT IS EXCLUDED OR EXEMPT FROM REGISTRATION. ADDITIONALLY, NORTHEAST COMMITTEE ON HOMELESSNESS MAY BE SUBJECT TO ADMINISTRATIVE FINES OF UP TO \$1,000 PER VIOLATION AND \$100 FOR EACH DAY THE VIOLATION CONTINUES. THIS ORDER SHALL TAKE EFFECT IMMEDIATELY.
