ORDER

AND NOW, THIS 8TH DAY OF NOVEMBER 2011, THE SECRETARY OF THE COMMONWEALTH, HAVING FOUND THAT OPERATION HELP THE CHILDREN, 2200 BEN FRANKLIN PARKWAY EAST 905A, PHILADELPHIA, PA 19130 IS NOT REGISTERED WITH THE DEPARTMENT'S BUREAU OF CHARITABLE ORGANIZATIONS, HAS FAILED TO RESPOND TO THE BUREAU'S REQUEST FOR INFORMATION, HAS FAILED TO SUBMIT ALL REQUIRED REGISTRATION MATERIALS, AND ALL ADMINISTRATIVE FEES; IN ACCORDANCE WITH THE PENNSYLVANIA SOLICITATION OF FUNDS FOR CHARITABLE PURPOSES ACT, 10 P.S. § 162.1, *ET SEQ.*, HEREBY ORDERS OPERATION HELP THE CHILDREN TO CEASE AND DESIST FROM SOLICITING CONTRIBUTIONS IN PENNSYLVANIA UNTIL SUCH TIME AS OPERATION HELP THE CHILDREN RESPONDS TO THE BUREAU AND DULY REGISTERS OR PROVIDES INFORMATION THAT IT IS EXCLUDED OR EXEMPT FROM REGISTRATION. ADDITIONALLY, OPERATION HELP THE CHILDREN MAY BE SUBJECT TO ADMINISTRATIVE FINES OF UP TO \$1,000. PER VIOLATION AND \$100 FOR EACH DAY THE VIOLATION CONTINUES. THIS ORDER SHALL TAKE EFFECT IMMEDIATELY.
