CEASE AND DESIST ORDER

AND NOW, THIS 16<sup>th</sup> DAY OF FEBRUARY, 2017, THE SECRETARY OF THE COMMONWEALTH, HAVING FOUND THAT PRIME STAGE, 520 JACKSON BOULEVARD, FREEDOM, PENNSYLVANIA, 15042, IS REGISTERED WITH THE DEPARTMENT OF STATE'S BUREAU OF CORPORATIONS AND CHARITABLE ORGANIZATIONS, REGISTRATION CERTIFICATE NUMBER 14913, THAT PRIME STAGE HAS FAILED TO SUBMIT REQUESTED DOCUMENTATION TO THE BUREAU; IN ACCORDANCE WITH THE PENNSYLVANIA SOLICITATION OF FUNDS FOR CHARITABLE PURPOSES ACT, 10 P.S. § 162.1 *ET SEQ.*, **HEREBY ORDERS PRIME STAGE TO CEASE AND DESIST** FROM SOLICITING CONTRIBUTIONS IN PENNSYLVANIA UNTIL SUCH TIME AS IT PROVIDES THE BUREAU WITH ALL PREVIOUSLY REQUESTED INFORMATION.

PRIME STAGE MAY ALSO BE SUBJECT TO FORMAL ADMINISTRATIVE ACTION, WHICH COULD RESULT IN THE IMPOSITION OF ADMINISTRATIVE FINES OF UP TO ONE THOUSAND DOLLARS (\$1,000) PER VIOLATION OF THE ACT PLUS AN ADDITIONAL PENALTY OF ONE HUNDRED DOLLARS (\$100) PER DAY FOR EACH DAY THE VIOLATION CONTINUES.

THIS ORDER SHALL TAKE EFFECT IMMEDIATELY.
