CEASE AND DESIST ORDER

AND NOW, THIS 16<sup>th</sup> DAY OF FEBRUARY, 2017, THE SECRETARY OF THE COMMONWEALTH, HAVING FOUND THAT SPAY AND SAVE, INC., P.O. BOX 122, LAFAYETTE HILL, PENNSYLVANIA, 19444, IS NOT REGISTERED, WITH THE DEPARTMENT OF STATE'S BUREAU OF CORPORATIONS AND CHARITABLE ORGANIZATIONS, AND THAT RESPONDENT HAS:

- 1) FAILED TO SUBMIT REQUESTED DOCUMENTATION TO THE BUREAU, AND
- 2) SOLICITED CONTRIBUTIONS IN THE COMMONWEALTH OF PENNSYLVANIA WHILE NOT REGISTERED,

IN ACCORDANCE WITH THE PENNSYLVANIA SOLICITATION OF FUNDS FOR CHARITABLE PURPOSES ACT, 10 P.S. § 162.1 *ET SEQ.*, **HEREBY ORDERS** SPAY AND SAVE, INC., TO **CEASE AND DESIST** FROM SOLICITING CONTRIBUTIONS IN PENNSYLVANIA UNTIL SUCH TIME AS IT PROVIDES THE BUREAU WITH ALL PREVIOUSLY REQUESTED INFORMATION AND DULY REGISTERS OR PROVIDES INFORMATION THAT IT IS EXCLUDED OR EXEMPT FROM REGISTRATION.

SPAY AND SAVE, INC., MAY ALSO BE SUBJECT TO FORMAL ADMINISTRATIVE ACTION, WHICH COULD RESULT IN THE IMPOSITION OF ADMINISTRATIVE FINES OF UP TO ONE THOUSAND DOLLARS (\$1,000) PER VIOLATION OF THE ACT PLUS AN ADDITIONAL PENALTY OF ONE HUNDRED DOLLARS (\$100) PER DAY FOR EACH DAY THE VIOLATION CONTINUES.

THIS ORDER SHALL TAKE EFFECT IMMEDIATELY.
