CEASE AND DESIST ORDER

AND NOW, THIS 29th DAY OF NOVEMBER, 2016, THE SECRETARY OF THE COMMONWEALTH, HAVING FOUND THAT VISTA LIFE INNOVATIONS (FORMERLY VISTA VOCATIONAL & LIFE SKILLS CENTER), 107 BRADLEY ROAD, MADISON, CONNECTICUT 06443, IS NOT REGISTERED WITH THE DEPARTMENT OF STATE'S BUREAU OF CORPORATIONS AND CHARITABLE ORGANIZATIONS; THAT VISTA LIFE INNOVATIONS HAS FAILED TO SUBMIT REQUESTED DOCUMENTATION TO THE BUREAU, AND HAS SOLICITED CONTRIBUTIONS IN PENNSYLVANIA WHILE NOT REGISTERED; IN ACCORDANCE WITH THE PENNSYLVANIA SOLICITATION OF FUNDS FOR CHARITABLE PURPOSES ACT, 10 P.S. § 162.1 *ET SEQ.*, HEARBY ORDERS VISTA LIFE INNOVATIONS TO CEASE AND DESIST FROM SOLICITING CONTRIBUTIONS IN PENNSYLVANIA UNTIL SUCH TIME AS IT PROVIDES THE BUREAU WITH ALL PREVIOUSLY REQUESTED INFORMATION AND DULY REGISTERS OR PROVIDES INFORMATION THAT IT IS EXCLUDED OR EXEMPT FROM REGISTRATION. ADDITIONALLY, VISTA LIFE INNOVATIONS MAY BE SUBJECT TO ADMINISTRATIVE FINES OF UP TO \$1,000 PER VIOLATION OF THE ACT AND \$100 FOR EACH DAY THE VIOLATION CONTINUES. THIS ORDER SHALL TAKE EFFECT IMMEDIATELY.
