## **PA Board of Accountancy**

### **Indiana County**

Robert Michael Tomasko, certificate no. CA013375L of Heilwood, Indiana County, had his certificate of certified public accountant and current license to practice public accounting suspended for failing to pay a \$1,000 civil penalty assessed by a December 2009 adjudication and order. The suspension was terminated on Feb. 4, 2010, when Tomasko paid the civil penalty. (01/21/10)

CY108385 of Gettysburg, Adams County, was ordered to pay a civil penalty of \$1,100 because he practiced cosmetology in a grossly incompetent manner by virtue of providing waxing services in a salon licensed only as a nail technology salon, having dirty nail tools on the manicure tables at four nail stations, having soiled towels in an open basket in the pedicure area and on chairs, counters and at stations throughout the salon, and for having violated the board's regulations by failing to store used towels in an enclosed container. Emily Nguyen and Michelle Terry, t/d/b/a Queen Nails, license no. CB119151 of Munhall, Allegheny County, was suspended for failing to pay a previously imposed civil penalty. (01/14/10)

CY193213 and CL178881, of North Versailles, Allegheny County, was ordered to pay a civil penalty of \$500 because it violated the practice act in that Cao practiced nail technology in a grossly incompetent and unethical manner by the use of harmful chemicals in the practice of the profession. CZ116545 of Malvern, Chester County, was ordered to pay a civil penalty of \$250 because Nguyen, while trading and doing business as Deluxe Nails, failed to have one timer clock available in the salon, failed to keep unused paper towels in a closed cabinet or closed towel dispenser, and failed to comply with sanitation, disinfection, and safety requirements. Nhi Thi Thuc Tran, license no. CL181822 of Phoenixville, Chester County, was revoked and ordered to pay a civil penalty of \$1,000 because he obtained his license by dishonest or unethical means. (02/03/10)

Dang Dao, t/d/b/a Kim's Nails, license no. CY194523 of Paoli, Chester County, was ordered to pay a civil penalty of \$850 because he practiced cosmetology in a grossly incompetent or unethical manner, he failed to maintain in a sanitary condition at all

times tools that come into contact with a client, and dirty tools were found at the work stations within respondent's nail technology salon. (02/04/10)

### **Delaware County**

Tamika N. Williams, t/d/b/a Cre8tive Concepts Hair Studio, license no. CB121262 of Lansdowne, Delaware County, was suspended for failing to pay a previously imposed civil penalty. (01/14/10)

Kelly A. Gallagher, license no. CO251011, of Drexel Hill, Delaware County, was suspended for failing to pay a previously imposed civil penalty. (01/14/10)

Jasmine Nails and Spa Salon, license no. CZ116690 of Chester, Delaware County, was assessed a civil penalty of \$1,700 because Jasmine Nails and Spa Salon practiced nail technology in a grossly incompetent or unethical manner by employing an unlicensed person to perform nail technology services within the nail technology salon and through the use of metal rasps in the practice of nail technology; failed to maintain tools that come into contact with a client in a sanitary condition at all times at four work stations and failed to have dirty towels in closed containers at three pedicure stations. Danielle M. Valente, license no. CO253931 of Glen Mills, Delaware County, was suspended for failing to pay a previously imposed civil penalty. (01/14/10)

Hanh Zuan Nguyen, t/d/b/a Anmy Nail Salon, license no. CY098615L of Ridley Park, Delaware County, was ordered to pay a civil penalty of \$400 because there was no wet sterilizer in the salon, there was not a complete first aid kit in the salon, there were dirty tools at the work stations, paper towels were kept out in the open rather than in a closed cabinet or towel dispenser, and dirty cloth towels were kept in an open container in the salon rather than in a closed container for soiled linen. Lee Hoang, t/d/b/a Nails 452, license nos. CL018095L and CZ115154 of Media, Delaware County, was ordered to pay a civil penalty of \$400 because he failed to maintain the salon in a safe, orderly, and sanitary condition in having dirty towels and dirty tools out in the open, failing to meet the minimum equipment requirements in that the salon did not have one adjustable chair, one wet sterilizer and one magnifying lamp. ### **Fayette County**

Dina Orlando Puskar, license no. CO196092L of Dawson, Fayette County, was ordered to pay a civil penalty of \$500 because Puskar violated the practice act in that she practiced as a cosmetology teacher without a valid Pennsylvania license. (01/04/10)

Lisa A. Joseph, t/d/b/a Lisa's Hairstyling and Tanning, license no. CO183513L of Connellsville, Fayette County, was indefinitely suspended and ordered to pay a civil penalty of \$500 because she failed to demonstrate she can practice safely and operate

CB117673 of York, York County, was ordered to pay a civil penalty of \$850 because of aiding and abetting the unlicensed practice of a profession, occupation or business, for practicing cosmetology in a grossly incompetent or unethical manner, and by designating a person in charge of respondents' cosmetology salon in the owners' absence who was not a cosmetologist.
