Van Chinh Luong t/d/b/a Nails Today, license nos. CY102203L and CZ115980 of Beaver, Beaver County, was ordered to pay a civil penalty of \$3,850 because Luong violated the practice act in that her salon, Nails Today, practiced nail technology in a grossly incompetent or unethical manner through the use of metal razor scraper tools, metal grater rasp tools, and razor tools in the practice of nail technology. Also, the nail technology salon failed to maintain tools that come into contact with a client in a

sanitary condition, failed to use a closed cabinet or towel dispenser for storage of clean towels within the nail technology salon, and failed to have a wet sterilizer, timer clock, and magnifying lamp in the esthetician salon. (04/12/10)

Arminee D. Miller, license no. CO267763 of West Chester, Chester County, was suspended for failing to pay a previously imposed civil penalty. (03/04/10)

Thanh T. Nguyen, license no. CO254726 of Phoenixville, Chester County, had her license declared void from the beginning and she was ordered cease and desist the practice of the profession because she procured a license to practice as a cosmetologist by dishonest or unethical means in violation of the licensing requirements set forth in the practice act. RS289741 of Rosemont, Montgomery County, was assessed a civil penalty of \$700 and a reprimand was placed on his board record, because Child failed to complete 14 hours of continuing education in timely and acceptable courses for the biennial reporting period of June 2, 2006 through May 31, 2008 and failed to provide accurate and truthful information in an application and/or in the statements and papers that accompany the application to the commission. Northampton County

Deborah Dahlinger, license no. RS271425 of Bethlehem, Northampton County, was ordered to pay a civil penalty of \$1,250 because Dahlinger violated the practice act by making a substantial misrepresentation and induced a party to a contract to break such contract for the purpose of creating a new contract. Dahlinger engaged in conduct in a real estate transaction which demonstrates bad faith, dishonesty, untrustworthiness or incompetency in violating the practice act by failing to exercise reasonable professional skill and care, and failing to deal honestly and in good faith.
