## **PA Board of Accountancy**

### **Allegheny County**

Arthur E. Desisto, license no. CA016466L of McKees Rocks, Allegheny County, was ordered to pay a civil penalty of \$600 and, within six months, complete four hours of continuing professional education because he did not complete the requisite 20 credit hours of continuing professional education during calendar year 2008 in the biennial period, and he did not complete the requisite 80 credit hours of continuing professional education during the applicable biennial period. ### **Crawford County**

Catherine Minnette Clepper, license no. CA034775R of Saegertown, Crawford County, was ordered to pay a civil penalty of \$600 and, within six months, complete 56 credit hours of continuing professional education overall, including 16 hours of accounting and auditing subjects, because she did not complete the requisite 16 credit hours of continuing professional education in accounting and auditing subjects during the biennial reporting period, did not complete the requisite 20 credit hours of continuing professional education during calendar years 2006 and 2007 in the biennial period, and did not complete the requisite 80 credit hours of continuing professional education during the biennial period.
