CY193588 and CZ115530 of West Chester, Chester County, was ordered to pay a civil penalty of \$3,150 because it practiced nail technology in a grossly incompetent or unethical manner; failed to maintain tools and instruments that come into contact with a client in a sanitary condition at all times; was not managed by the salon owner or a person in charge designated by the salon owner; failed to have the current salon license present at the time of inspection; and aided and abetted the unlicensed practice of a profession, occupation or business.
