CY106773, of Shillington, Berks County, was ordered to pay a civil penalty in the amount of \$1,150 and costs of investigation in the amount of \$18.94 because it did not keep unused cloth towels in a closed cabinet, had an uncovered waste container and practiced the profession in a grossly incompetent or unethical manner through the use of a credo tool and multiple razor blades. Innovative Hair Designs, license no. CB122332, of Temple, Berks County, was ordered to pay a civil penalty in the amount of \$500 and costs of investigation in the amount of \$28.52 because it practiced cosmetology in a grossly incompetent and/or unethical manner through the possession of a metal rasp. (05/07/12)

Estetica El Mexicano Unisex, license no. CB118886, of Reading, Berks County, was ordered to pay a civil penalty in the amount of \$3,100 and costs of investigation in the amount of \$71.30 because it acted with gross incompetency by employing three unlicensed individuals to perform cosmetology services, aided and abetted the unlicensed practice of three individuals of a profession, business or occupation, and neither the owners nor a designated person was readily available in person to Bureau inspectors during regular business hours. Blair County

Andrea L. Pollack, license no. CO224291L, of Hollidaysburg, Blair County was ordered to pay a civil penalty of \$500 because she provided cosmetology services in a salon while her license was lapsed as a second offense. (05/07/12)

Bucks County

Michelle A. Miller, license no. CL006673L, of Jamison, Bucks County was ordered to pay a civil penalty of \$1,000 because she practiced nail technology on an expired license as a third offense. (05/07/12)

Chester County

Modern Nail and Spa, license nos. CY193801 & CZ115660, of Paoli, Chester County, was ordered to pay a civil penalty in the amount of \$3,100 and costs of investigation in the amount of \$71.42 because it had neither the owner nor a designated person in charge of the salon readily available in person to Bureau inspectors during business hours, dirty tools were found in cosmetology salon when tools that come in contact with clients are to be kept in a sanitary condition at all times, it permitted cosmetology to be practiced in a grossly incompetent and/or unethical manner by permitting an employee without an esthetician license to perform esthetician services in the salon, it aided and abetted the unlicensed practice of a profession, business or occupation by permitting an unlicensed individual to practice esthetics in the salon, it failed to keep clean paper towels in a closed cabinet or closed towel dispenser, and dirty tools were found in esthetician salon when tools that come in contact with clients are to be kept in a sanitary condition at all times. Blessed Image Cuts, license no. CB117630, of Downingtown, Chester County, was ordered to pay a civil penalty in the amount of \$1,450 and costs of investigation in the amount of \$53.57 because it acted with gross incompetency by employing an unlicensed individual to perform cosmetology services, aided and abetted the unlicensed practice of a profession, business or occupation, failed to have the salon license in its possession in the salon, failed to have a covered waste container, failed to maintain tools, instruments, utensils and appliances that come into contact with a client in a sanitary condition at all times, failed to have a complete first aid kit in the salon and failed to have a reception desk in the salon. Advanced Nail Care, license no. CY098297L, of Phoenixville, Chester County, was ordered to pay a civil penalty in the amount of \$2,400 because it practiced the profession in a grossly incompetent or unethical manner through the use of metal rasp tools, and failed to maintain tools and instruments that come into contact with a client in a sanitary condition at all times. Delaware County

Inna Melamed t/d/b/a Professional House of Hair, license no. CB089807L, of Upper Darby, Delaware County, was ordered to pay a civil penalty of \$200 because the salon failed to have a complete first aid kit, failed to have a covered waste container, and failed to keep dirty towels in a closed container. (05/07/12)

Ridley Nail and Spa, license nos. CY195152 & CZ116750, of Folsom, Delaware County, was ordered to pay a civil penalty in the amount of \$2,000 and costs of investigation in the amount of \$71.42 because it acted with gross incompetency by allowing an unlicensed individual to perform nail technology services on a customer, aided and abetted the unlicensed practice of a profession, business or occupation, failed to keep unused disposable paper towels in a closed cabinet or closed towel dispenser, and as both a nail technology salon and as an esthetician salon, failed to maintain tools, instruments, utensils and appliances that come into contact with a client in a sanitary condition at all times, and failed to place used cloth towels in a closed container for soiled linens. Great Clips, license no. CB119725 of Wayne, Delaware County, was ordered to pay a civil penalty of \$200 and costs of investigation in the amount of \$38.70 because the cosmetology salon was not being managed by the salon owner or a licensee designated by the salon owner; and because all areas of cosmetology salon, including the floors and lavatories, were not maintained in a safe, orderly and sanitary condition. (05/07/12)

Erie County

Love Nails, license no. CY196300, of Erie, Erie County, was ordered to pay a civil penalty in the amount of \$1,600 and costs of investigation in the amount of \$107.59 because it acted with gross incompetency or in a dishonest or unethical manner by having three razor tools in the nail technology salon, and failed to display its current license or a copy of its application in a conspicuous place in the salon. (05/07/12)

Lehigh County

Creative Nails, license no. CY194308 of Allentown, Lehigh County, was ordered to pay a civil penalty in the amount of \$1,500 and costs of investigation in the amount of \$28.08 because it practiced nail technology in a grossly incompetent and/or unethical manner through the possession of credo tools and a metal file in the salon. (05/07/12)

Luzerne County

Get Nailed, license no. CY102882L, of Wilkes-Barre, Luzerne County, was ordered to pay a civil penalty of \$1,100 because it failed to display, at or near its main entrance, a sign that is clearly visible indicating to the public that it is a nail technology salon; practiced nail technology in a grossly incompetent and/or unethical manner through the use of a metal rasp tool; and practiced nail technology in a grossly incompetent and/or unethical manner through the use of a metal razor tool. Montgomery County

Saimi Kirmani, t/d/b/a Miracle Brows, unlicensed, of King of Prussia, Montgomery County was ordered to pay a civil penalty of \$1,000 because she provided cosmetology services in a salon that was not currently licensed as a second offense. (05/07/12)

Platinum Hair Salon and Skin Spa, license no. CB123185 of Trappe, Montgomery County, was ordered to pay a civil penalty in the amount of \$500 and costs of investigation in the amount of \$935 because it used part of its salon for a purpose other than performing cosmetology services. (05/07/12)

Dena's Nails, license no. CY108200, of Wyncote, Montgomery County, was ordered to pay a civil penalty of \$1,000 and the costs of investigation in the amount of \$68.49 because it practiced nail technology in a grossly incompetent and/or unethical manner through the use of a razor scraper toll and practiced nail technology in a grossly incompetent and/or unethical manner through the use of a metal rasp tool. Philadelphia County

Brazilian Hair Style, license no. CB120852, of Philadelphia, Philadelphia County, was ordered to pay a civil penalty in the amount of \$4,550 and costs of investigation in the amount of \$56.16 because it had neither the owner nor a designated person readily available in person to Bureau inspectors during regular business hours, acted with gross incompetency by employing two unlicensed employees, aided and abetted the unlicensed practice of two individuals of a profession, business or occupation, and failed to have a closed container for soiled linens. Pike County

Pink Nails, license no. CY195830, of Milford, Pike County, was ordered to pay a civil penalty in the amount of \$1,500 and costs of investigation in the amount of \$77.22 because it acted with gross incompetency or in a dishonest or unethical manner by having credo tools with blades in its salon (05/07/12)

Union County

Regal Nails Salon and Spa, license no. CY194935 of Lewisburg, Union County, was ordered to pay a civil penalty in the amount of \$2,650 and costs of investigation in the amount of \$85.56 because it acted with gross incompetency by employing an unlicensed employee, aided and abetted the unlicensed practice of a profession, business or occupation, failed to immediately place used cloth towels in a closed container for soiled linen, failed to have a complete first aid kit, and offered esthetician services without having an esthetician salon license.
