CA010811L of Wexford, Allegheny County, agreed to the permanent voluntary surrender of his certificate and license to practice as a certified public accountant in the Commonwealth of Pennsylvania, because he was found guilty, pled guilty or pled nolo contendere to any felony, any crime an element of which is dishonesty or fraud, and/or any Federal or state revenue law or the revenue law of any foreign jurisdiction and he has been convicted of any felony. Richard Thomas Hardy, Jr, registration no. RA007942X of Shickshinny, Luzerne County, was ordered to pay a civil penalty of \$11,250, costs of investigation of \$478.65, and his license will be publicly reprimanded, because he engaged in the practice or offered to engage in the practice of architecture or used the title of architect or used any sign, card or devise implying he was competent to engage in the practice of architecture during 15 biennial renewal periods in which he failed to hold a currently valid certificate issued pursuant to the Act, with the failure to hold a valid certificate during each renewal period constituting a separate violation under the Act. James M Morrissey, an unlicensed designer of Flourtown, Montgomery County, was ordered to pay a civil penalty of \$7000 and to cease and desist from the practice of architecture until such time as he becomes because he engaged in the practice, or offered to engage in the practice of architecture in this state, or used any sign, card or device implying that such individual is competent to engage in the practice of architecture without holding a currently valid certificate and created an LLC to offer to, to practice, or to imply the firm was competent to engage in the practice of architecture all in violation of the requirement for him to be a licensed architect as owner of the firm. Morrissey Design LLC, an unlicensed limited liability company in Flourtown, Montgomery County, was ordered to pay a civil penalty of \$6000 and to cease and desist from the practice of architecture until such time as the limited liability company has an owner or partial owner who is licensed to practice architecture in the Commonwealth of Pennsylvania. These actions were undertaken because James M. Morrissey, an unlicensed person in this Commonwealth, was the sole owner of the firm, Morrissey Design LLC, and that the firm was offering to and providing architectural services while having no owner of the LLC licensed in any state as an architect and the limited liability company engaged in the practice, or offered to engage in the practice of architecture in this state, or used any sign, card or device implying that such limited liability company is competent to engage in the practice of architecture without holding a currently valid certificate in the Commonwealth of Pennsylvania. BV004644L of Philadelphia, Philadelphia County, was ordered to pay a civil penalty of five thousand dollars (\$5,000) and pay costs of investigation of four hundred twenty-one dollars (\$421); and ordered to attend and successfully complete at least fourteen (14) hours of remedial education because she engaged in incompetence, gross negligence, or other malpractice, or the departure from, or failure to conform to, the standards of acceptable and prevailing veterinary medical practice; failed to provide documentary evidence of a patient's illness, hospital care and treatment and serve as a basis for review, study and evaluation of the care and treatment rendered by the veterinarian and further require that a veterinary medical record be kept in a problem-oriented or similar format that allows veterinarian, by reading the record, to proceed with the care and treatment of the patient and allow the Board or other agency to determine the advice and treatment recommended and performed; failed to maintain veterinary medical records which completely reflect the evaluation and treatment of a patient and/or identify the treating individual after each chart entry and/or document medical or surgical treatment and/or document other diagnostic, corrective or therapeutic procedures and/or document drugs administered, prescribed or dispensed and/or document surgical and dental procedures, including type and dosage of anesthesia and/or document communication with a client; and failed to maintain required veterinary medical, surgical and/or diagnostic procedure logs and/or medical records. Susquehanna County

Ellen Louise Johnson, license number BV007498L, of Thompson, Susquehanna County, was ordered to cease and desist from using her veterinary and/or DEA and/or professional license to order/obtain Lorazepam, or any other prescription drug, for her own and/or any human's personal use; cease and desist from self-medicating with Lorazepam or any other prescription drug without a valid written prescription from a health care provider providing health care to Respondent and filled at a pharmacy as required by law; pay a civil penalty of one thousand dollars (\$1,000.00); and pay costs of investigation of five hundred dollars (\$500.00), because she engaged in illegal practices in or connected with the practice of veterinary medicine.
