PC003817, of Durham, North Carolina, permanently and voluntarily surrendered his license to practice as a licensed professional counselor in the Commonwealth of Pennsylvania, because he engaged in sexual intimacies and/or a romantic relationship with a current client/patient, and failed to create, safeguard, and/or maintain records of numerous individual counseling sessions. ### **Chester County**

Caln Auto Sales and Micah Joseph Kepiro, license no. MV115826L, of Coatesville, Chester County, were ordered to pay a civil penalty of \$1,000.00, and the costs of investigation of \$449.02, because they committed any act or engaged in conduct in connection with the sale of vehicles which clearly demonstrates unprofessional conduct or incompetency to operate as a licensee. ### **Dauphin County**

Colby W. Troutman, license no. MV136584L, of Harrisburg, Dauphin County, was assessed a \$2000 civil penalty, issued a reprimand and placed on probation for no less than one year based on pleading guilty of a felony and crimes of moral turpitude and his convictions occurred while his license was in force. (11/08/17)

Joshua I. Perry, license no. MV234787, of Middletown, Dauphin County, permanently and voluntarily surrendered his license, because he was convicted, or entered a plea of guilty, or entered a plea of nolo contendere in a court of competent jurisdiction in this or any other state or Federal jurisdiction of a crime involving moral turpitude, and had been convicted of any felony. (3/13/18)

### **Lehigh County**

Ashraf A. Shedid, license no. MV177653, of Allentown, Lehigh County, permanently and voluntarily surrendered his license to practice as a vehicle salesperson in the Commonwealth of Pennsylvania, because he engaged in unprofessional conduct by consigning or transferring temporary registration plates issued by PennDOT. (3/13/18)

### **Montgomery County**

Richard L. O'Donnell, Sr., license no. MV043008L of Penllyn, Montgomery County, was indefinitely suspended stayed to probation for no less than two years based on being convicted of a crime of moral turpitude. (11/08/17)

### **Northampton County**

Salvatore J. Caroprese, license no. MV251269, of Easton, Northampton County, had his license to practice as a vehicle salesperson in the Commonwealth of Pennsylvania revoked, because he was convicted, or entered a plea of guilty, or entered a plea of nolo contendere in a court of competent jurisdiction in this or any other state or Federal jurisdiction of forgery, embezzlement, obtaining money under false pretenses, extortion, conspiracy to defraud, bribery, odometer tampering or any other crime involving moral turpitude while his license was in force or within five years prior to the application for or issuance of a license. ### **Northumberland County**

Ryan Cortazzo, of Nazareth, Northampton County, was ordered to pay a civil penalty of one thousand six hundred dollars (\$1,600); and pay costs of investigation of four hundred dollars (\$400), because he acted as a vehicle dealer in the Commonwealth of Pennsylvania without possessing a license. (03/13/18)

### **Philadelphia County**

Stephen A. Jolicoeur, of Philadelphia, Philadelphia County, was ordered to pay a civil penalty of two thousand five hundred dollars, an assessment for the costs of investigation of five hundred nine dollars and eighty-six cents, and ordered to immediately cease and desist from performing any activity requiring a license to practice as a vehicle dealer in the Commonwealth of Pennsylvania and refrain from performing any activity which requires authorization unless and until the board issues the appropriate authorization to practice the profession; because he operated as a vehicle dealer without first obtaining the required license. (3/13/18)

### **Out of State**

John Carrothers, PA license no. MV166539L, of Toms River, New Jersey, was indefinitely suspended for no less than six months based on felony convictions and crimes of moral turpitude. (11/08/17)

Massimo Motor Sports LLC, PA license no. WD000846, of Garland, Texas, was ordered to pay a civil penalty of \$20,875 and investigative costs of \$3,595.79, for engaging in the business of a vehicle distributor in Pennsylvania when it was not licensed as required under this Act. (03/13/18)

## **[PA Board of Veterinary Medicine](#)**

### **Lycoming County**

Bradford P. Baker, license no. BV008039L, of Linden, Lycoming County, had a public reprimand placed on his permanent disciplinary record with the Board, was ordered to pay a civil penalty of five thousand dollars, and to successfully complete at least ten hours of remedial education on the topics of Veterinary Medical Records and Diabetes, because he engaged in incompetence, gross negligence or other malpractice; or departed from, or failed to conform to, the standards of acceptable and prevailing veterinary medical practice; and failed to maintain required veterinary medical, surgical and/or diagnostic procedure logs and/or medical records. (3/09/18)

## **Out of State**

Jonathan Edward Jenkins, PA license no. BV011690, of Georgetown, Texas, was ordered to pay a civil penalty of three thousand dollars, costs of investigation of five hundred dollars and, attend and successfully complete the online course: “Veterinary Medical Records”, because he engaged in incompetence, gross negligence, or other malpractice, or the departure from, or failure to conform to, the standards of acceptable and prevailing veterinary medical practice; violated the Board's regulations at 49 Pa Code §31.21, Principle 7(d) which states that: “Veterinarians shall practice in accordance with current advancements and acceptable and prevailing standards of care in veterinary medicine, including using current proven techniques, drugs and scientific research that may affect treatment decisions. Veterinarians shall practice in accordance with advancements and acceptable and prevailing standards of veterinary medical practice in this Commonwealth related to the pharmacologic properties, indications and contraindications of drugs and biologics”; violated the Board's recordkeeping regulations at 49 Code §31.22 by failing to maintain required veterinary medical, surgical and/or diagnostic procedure logs and/or medical records; violated the Board's regulations at 49 Pa Code §31.21, Principle 7(e) which states: “Veterinarians shall explain the benefits and reasonably anticipated significant potential risks of treatment options to clients. When the client or client’s agent is present, veterinarians shall document, by signature, the client’s consent for euthanasia and other treatments that have significant potential risks”. (03/09/18)

Ross Thomas Russell, PA license no. BV012257, of Tampa, Florida, was ordered to pay a civil penalty of one thousand dollars and his license was placed on probation to run concurrently with the probation imposed by the Indiana Board, because he violated the Act at Section 21(13), 63 P.S. § 485.21(13), by being subject to disciplinary action in another State of a license to practice veterinary medicine in that State on grounds similar to those which in this State allow disciplinary proceedings. (3/09/18)
