Dear Members of the General Assembly:

As Acting Secretary of the Commonwealth, I am pleased to report on the administration of voter registration in Pennsylvania for calendar year 2021. I trust you will find this information useful.

Voter registration in Pennsylvania is a joint effort between county and state officials. In 2021, the Department of State continued its partnership with the state's 67 county election boards and voter registration commissions. The Department supported counties in a variety of ways, including through voter education materials and through voter registration and mail ballot application forms available both in print and online in multiple languages. The Department continues its collaboration with the state agencies designated under the National Voter Registration Act of 1993 (NVRA) to administer voter registration programs.

The Statewide Uniform Registry of Electors (SURE) system, implemented in Pennsylvania through Act 3 of 2002, is the bedrock of Pennsylvania's voter registration system. As of December 31, 2021, there were approximately 8.7 million registered voters in Pennsylvania. In 2021, the department began its work to update the aging SURE system and is working closely with county officials to implement the new SURE system after the 2022 general election.

The Department remains committed to fulfilling its responsibilities under the NVRA and Pennsylvania's voter registration law. The Department will continue to promote voter registration and civic engagement through its outreach efforts across the Commonwealth.

EXECUTIVE SUMMARY

In 2021 the Department of State (Department) worked closely with the public, each of the 67-county boards of elections, Commonwealth agencies designated with voter registration responsibilities, and voter registration advocacy groups. This report represents a summary of statistics and initiatives that support voter registration administration in Pennsylvania. The data contained in this report reflects transactions processed through the SURE system between January 1, 2021 and December 31, 2021.

All 2021 data referenced in this report is available in its entirety within the <u>Annual Report Data</u> section starting on page 32 of this report. Data from previous years can be found in the respective annual reports, which are available online at <u>www.dos.pa.gov.</u>

<u>Effectiveness of Voter Registration Modernization Efforts</u>

Online Voter Registration (OVR)

The Pennsylvania Online Voter Registration (OVR) Application was deployed on August 27, 2015. The OVR application provides residents of Pennsylvania with the opportunity to register to vote or change an existing voter registration online and electronically submit voter registration data to their county voter registration office for processing. The Department actively engaged election stakeholders outside of the Department, such as county election directors, the elections advocacy community, and Pennsylvania citizens.

To ensure that the final product would be universally useable, DOS engaged the Center for Civic Design to review the text and the logical flow of information. The Center also field tested the application in an urban and a rural community and provided additional feedback that informed the product. This highly interactive development process engaged stakeholders outside of the agency and tested the final product with end users before it was launched, resulting in a better product overall and one that has been embraced by Pennsylvania voters in overwhelming numbers.

The Department developed a secure connection with the Pennsylvania Department of Transportation (PennDOT) through which the Department can obtain digital images of signatures for those applicants who are PennDOT clients. For registrants who are not PennDOT clients, the OVR application provides applicants with the options to print, sign and mail a hard copy application or request that a signature form be mailed to them to complete the application process or to upload a digital image their signature if the applicant could not be verified through PennDOT.

OVR WebAPI and Agency Voter Registration

From its launch in 2015 through the end of 2021, OVR has been the preferred method of voter registration over traditional paper voter registration applications. Nearly 2.9 million new and change applications have been submitted via OVR versus 2 million new and change applications submitted on paper. More than 250,000 of the OVR applications were submitted through the Department of State's Web Application Programming Interface (Web API), including more than 40,000 applications submitted by state agencies as part of the Commonwealth's compliance with the National Voter

Registration Act (NVRA). Web API is a programmatic interface that allows a voter registration agency or an organization conducting voter registration activities to connect to OVR to facilitate voter registration through a custom application or website. Unlike traditional paper voter registration drives, a voter registration application submitted through Web API can be traced to a specific organization to provide greater auditability and accountability.

The Department of Human Services (DHS) was the first agency to establish a Web API service for its clients. API has significantly enhanced this agency's ability to efficiently meet its NVRA responsibilities by providing a mechanism to register to vote for remote and/or electronic interactions with its clients. Indeed, the Department of Human Services accounts for the vast majority of voter registration opportunities at NVRA agencies.

In December 2021, DOS worked with PennDOT to update Motor Voter services to ensure that they are fully compliant with the NVRA. For example, the voter registration transactions that are done online and through the mail when a voter makes certain updates to their driver record now incorporate updated instructions that make voter registration an opt-out option to ensure that changes are transmitted from PennDOT to county voter registration commissions for all citizens who are qualified to be registered. As part of its SURE modernization project, DOS plans to make additional enhancements to Motor Voter that will expand voter registration opportunities and streamline the process of transmitting voter registration applications to counties.

Enhanced Voter List Maintenance

One of the primary benefits of the Department's initiative to update the aging SURE system is the additional tools counties will have to manage their workflow, including a user dashboard that provides an overview of unprocessed work and task lists. This functionality will be especially helpful in managing voter list maintenance activities that include multi-step voter removal programs, such the National Change of Address Program and the Five-year Notice Program.

Also in 2015, Pennsylvania joined the Electronic Registration Information Center (ERIC). ERIC is a non-profit organization with the sole mission of assisting states to improve the accuracy of America's voter rolls and increase access to voter registration for all eligible citizens. ERIC is governed and managed by the member states and was formed in 2012 with assistance from The Pew Charitable Trusts. ERIC membership has grown from the original 7 states to 31 states and the District of Columbia. ERIC is an invaluable resource for member states.

Pennsylvania's membership in ERIC has benefited the Commonwealth by giving the department and county voter registration commissions additional reliable data to maintain our voter rolls and to connect qualified unregistered citizens with the forms and information they need to register. In addition to facilitating the statutorily mandated voter removal programs, ERIC's data also enables Pennsylvania to identify additional potential duplicate records and additional in-state and cross-state movers. Together with the additional visibility into the county's workflow through the updated SURE system, ERIC's data will further improve data quality and streamline voter list maintenance activities for county voter registration commissions. ERIC could also provide Pennsylvania with access to additional deceased voter data via an agreement with the Social Security Administration. However,

the Pennsylvania Election Code limits the sources from which the county voter registration commissions can obtain information regarding deceased voters, and thus prevents the counties from utilizing this data.

Opportunities for Improvement

The Commonwealth has made great strides over the past several years to modernize voter registration and voter list maintenance activities, but there is more work to be done.

- First, DOS plans to expand WebAPI to other state agencies that must provide voter registration opportunities to make it easier to register and to reduce paper applications coming from these agencies to counties. This will reduce data entry errors and it will enhance reporting from these agencies.
- DOS also wants to utilize WebAPI to make Motor Voter transactions as close to real-time as possible, meaning voter registration applications from PennDOT will enter the workflow of counties on an ongoing basis instead of being uploaded in batches at specific intervals.
- Finally, DOS wants to fully utilize the services available through its ERIC membership, but this will require amendments to Section 1505 of Pennsylvania's voter registration law at 25 Pa.C.S. § 1505.

Voter Registration Statistics

Through the Statewide Uniform Registry of Electors (SURE) system, the county voter registration commissions maintain a complete list of all eligible registered voters in the Commonwealth. As of December 2021, there were 8,676,127 registered voters. This was an overall decrease of voters (3.64%) since the end of the previous calendar year (December 2020) but was an overall increase of voters since the end of the municipal election year of 2017 (2.86%) – the last municipal election cycle that occurred after a presidential election. The charts in this section represent a high-level snapshot of the change in voter registration over both the previous calendar year and the four-year period since the end of 2017. Details broken down by county and party can be found in Appendices A and B.


Total Voter Registration by Party

The chart below depicts change in voter registration over a four-year period since the end of 2017 and whether that change represented growth or decline in general party affiliation. The 2017 data was carried over from the 2017 annual report on voter registration. Therefore, the data from 2017 is as of Dec 31, 2017.


The chart below portrays change in party affiliation over a four-year period between 2017–2021.



Areas of Growth and Decline

This section shows the voter registration growth and decline as compared to the previous year and over a four-year period. The charts are done in two parts: 1) Growth and decline in registration for this year as compared to previous year, and 2) growth and decline in registration over the four-year period between the end of 2017 and the end of 2021. For each section, the charts represent the highest counties within each category with their rate of growth or decline when compared to either last year's totals or totals from 2017. The tables show the growths or decline for all the 67 counties.

Highest Overall Registration Growth and Highest Overall Decline Since 2020 The chart below shows the five (5) counties with the highest overall registration growth, and the five (5) with the highest decline since last year.



List Maintenance

This section summarizes voter list maintenance activities conducted during the 2021 calendar year. Generally, "list maintenance" can be described as the process county election and voter registration officials use to manage voter registration rolls to ensure they are accurate. Both state and county election officials follow careful and appropriate steps, in compliance with federal and state laws, to determine whether a voter should be marked as *Inactive* or removed from the registration rolls.

List Maintenance Mailings


During 2021, counties sent more than 622,900 notices to voters: 98,133 Five-year notices; 192,735 National Change of Address (NCOA) notices; 6,660 duplicates notices; 38,854 In-State Update notices; 76,148 Out-of-State Update notices; and 210,409 Address Verification Notices (AVNs).

When reviewing list maintenance activity summaries below, the voter responses to each notice can be summarized into six (6) broad categories:

- Non-Response: The voter never responded to the mailed notice.
- **Returned Undeliverable:** The notice could not be delivered via mail and was returned as undeliverable to the county voter registration commission.
- Returned Confirmation: The voter responded to the notice and confirmed their eligibility.
- **Voter Moved In-County:** The voter responded to the notice and confirmed they have moved to a new address within the county.
- **Voter Moved Out-of-County:** The voter responded to the notice and confirmed they no longer reside in the county but live elsewhere in Pennsylvania.
- **Voter Moved Out of State:** The voter responded to the notice and confirmed they have moved outside of Pennsylvania.


Figures in this section are only representative of actions taken by December 31, 2021, as recorded by the counties in the SURE system. For example, if additional responses to notices were received after that date they will not be represented below as the data is only point-in-time.

2021 Five-Year Notice Responses Summary



The Five-Year Notice (FYN) is a statutorily required, one-step mailing process. It is sent via forwardable mail. The purpose of this notice is to contact voters who have not had any activity on their record or have not voted within five years. Upon generation of this notice, the voter's record enters a list maintenance window, during which the voter record remains on the rolls but is updated to *Inactive* status. If the voter does not take any action or vote before the expiration of the list maintenance window, the voter's record is removed from the registration polls. The FYN provides an opportunity for the voter to respond so they may be reinstated to *Active* status. Upon a return to *Active*, the window to eventually cancel the voter record stops. Appendix D1 represents the activity recorded by counties on Five-Year Notice mailings.

2021 NCOA Notice Summary




The NCOA is a statutorily required two-step mailing process. Both notices are sent via forwardable mail. The first mailing, based on data received from the U.S. Postal Service (USPS) through its National Change of Address Program, is a notice which requires the voter to specify whether they have moved. Then, depending on their response, county officials update their records accordingly. These notices provide an opportunity for the voter to confirm their address or provide an update with their latest information to county officials.

Following the initial NCOA notice mailing, county officials send a second notice to voters who did not respond to the first mailing, or where the initial NCOA notice was returned as undeliverable. This second notice is commonly referred to as the Address Verification Notice (AVN). Mailing of the AVN, the record is marked *Inactive*, triggering a waiting period before the voter record can be removed from the registration rolls. The period lasts until two federal general elections have passed. If the voter takes an action to update their record or vote within the waiting period, the voter record is returned to *Active* status, and the voter record is no longer eligible for removal. For example, if a voter was marked as *Inactive* in 2021 during list maintenance activities, and they do not make any changes on their record or vote, the voter would be removed after the 2024 general election. Approximately, 128,524 voters were marked *Inactive* following the 2021 NCOA list maintenance process. Appendix D2 represents the activity recorded by counties on NCOA mailings.


2021 ERIC Duplicate Notices

As part of the Department's membership in the ERIC program, data is provided to county officials which identifies a pair of voter records that may be the same person. This includes non-cancelled

records (i.e. *Active* and *Inactive* status voters) for comparison. Pairs of voter records are identified for review to confirm whether the same person is potentially registered more than one time in Pennsylvania, or in Pennsylvania and another state. After review, county officials update the voter's record, depending on that voter's response to the notice. During the 2021 calendar year, approximately 6,660 duplicate notices were sent to the voter's address on record. The chart below represents summary of the mailing responses. Appendix D3 represents the activity recorded by counties on ERIC Duplicate Notice mailings.




2021 ERIC In-State Moves



Like other list maintenance mailing processes, data from the ERIC program that identifies potential updates to voter records where a voter may have moved to another location is provided to counties. This type of ERIC program data shows information where a voter within Pennsylvania appears to have newer information from another record set. The supplemental data set is from the Pennsylvania Department of Transportation (PennDOT).

This process is a one-step mailing procedure. Once the notice is queued and confirmed, the affected voter records are updated to *Inactive* status. Depending on the response to the mailer or non-response, the voter's record may be updated to *Active*, remain in *Inactive* status, or be *Cancelled*. During 2021, approximately 38,551 notices were mailed to voters. Appendix D4 represents the activity recorded by counties on ERIC In-state move mailings.


2021 ERIC Out-of-State Moves



The data for potential out-of-state updates or moves are provided by the ERIC program. This process captures information where a voter within Pennsylvania appears to match another record from out of state that contains newer information. This may be an indication that the voter no longer resides in the state. Therefore, any identified records are sent a notice for confirmation.

This process is a one-step mailing procedure. Once the notice is queued and confirmed, the affected voter records are updated to *Inactive* status. Depending on the response to the mailer or non-response, the voter's record may be updated to *Active*, remain in *Inactive* status, or be *Cancelled*. During 2021, approximately 76,148 notices were mailed out to voters. Appendix D5 represents the activity recorded by counties on ERIC out of state move mailings.


2021 Address Verification Notices (AVNs)



As another method of keeping voter registration rolls accurate, county officials can send out Address Verification Notices (AVNs) to determine if the voter is still eligible to vote. In addition to the list maintenance activities described above, counties send this notice to inactive voter records when they receive an undeliverable notice at the county office after they attempt to contact the voter. For example, a voter signed up to register to vote, but the voter identification card could not be delivered by USPS. In 2021, approximately 210,409 AVNs were mailed to voters by county officials. The chart above summarizes the responses received by county officials as of December 31, 2021. Appendix D6 represents the activity recorded by counties on AVN mailings.

PennDOT Change of Address Summary

In addition to registering to vote through more traditional means like paper or online voter registration, the National Voter Registration Act of 1993 (NVRA) required states to incorporate voter registration opportunities into the driver's licensing application process at state motor vehicle authorities. As part of that process, voters have an opportunity to update their voter registration with their latest information to ensure the voter registration rolls are accurate, which is otherwise known as the change of address process. During the 2021 calendar year, 490,272 change applications were submitted from PennDOT to DOS for county officials to process and update voter records. Appendix D7 represents the activity recorded by counties on PennDOT COA transactions.



Voter Registration Cancellations


During 2021, the SURE system recorded approximately 553,785 voter registration cancellations. When a voter registration is cancelled, the record is tagged in the SURE system to identify the reason for cancellation. County boards may cancel the registration of both *Active* and *Inactive* voters. Note: voters are marked as *Inactive* if they do not respond to a county mailing asking them to confirm their residence, or if a mailing to a voter was returned by the USPS as undeliverable. For example, voters may be sent a mailing based on data the county receives in partnership with ERIC or when the voter fails to take some sort of action on their record within five years. *See* 25 Pa. C.S. §§ 1901(b)(1), 1901(b)(3), and 1901(c). See Appendix D for details broken out by county.



National Voter Registration Act (NVRA)

NVRA Agency Registrations

The National Voter Registration Act (NVRA) requires that "(1) Each state shall designate agencies for the registration of voters in election for Federal offices. (2) Each state shall designate as voter registration agencies –

(A) all offices in the state that provide public assistance; and (B) all offices in the State that provide State-funded programs primarily engaged in providing service to persons with disabilities." See 52 U.S.C. § 20506. Pennsylvania, through its voter registration law, has incorporated these requirements for all elections. See 25 Pa.C.S. § 1325.

In light of these mandates, the Department continues to work with the covered agencies to ensure that the requirements of federal and state law are met. Since 2010, the Department has used barcoded registration forms that allow the Department to identify the source agency of registrations to track the Department's efforts more accurately, and subsequently ensure that agency efforts comply with the requirements of the NVRA and the Pennsylvania voter registration law.


On December 2, 2017, the Pennsylvania Department of Human Services (DHS) became the first

Commonwealth agency to publicly deploy an online voter registration service with the Department. Through this online service, DHS clients submitted more than 32,600 applications in 2021. The Department also worked with the Department of Labor & Industry's (L&I) Office of Vocational Rehabilitation and the Department of Health's Women, Infants and Children (WIC) program to deploy online services. Moving forward, the Department continues to look for other opportunities to modernize voter registration with state agencies. Appendix C2 shows the voter registration applications processed from each agency by county.

Pennsylvania Department of Transportation

Since 1995, the Pennsylvania Department of Transportation (PennDOT) has played an integral role in voter registration through what is commonly known as the "Motor Voter" registration process.

In 2003, the process became electronic. Motor Voter provides Commonwealth citizens with an opportunity to apply to register to vote while receiving or renewing their driver's license or photo ID at a PennDOT center, as well as the opportunity to update their registration in-person and online.

PennDOT voter registration applications can be grouped into two main groups: 1) Initial applications to register to vote (otherwise known as new applications); 2) Change of Address applications to update the registrant's address on an existing record (otherwise known as change applications).

Application Process to Register to Vote at a PennDOT Center

PennDOT customers visit a photo license center with a driver's license application card provided by PennDOT. The application card contains a printed two-dimensional bar code. The bar code is scanned and the computer system determines the customer's age. It then determines which customers will be at least 18 years old by the date of the next election and asks if the customer wishes to apply to register to vote.

The program is designed to ask customers if they are currently registered to vote. If not, they are provided the opportunity to apply to register:

- If a customer is not an eligible U.S. citizen, they do not see the Motor Voterapplication;
- Customers must confirm that they are U.S. citizens and qualified to register in the Commonwealth;
- Customers who choose to apply to register to vote are asked to confirm their county of residence and indicate a party preference. The customer is asked for optional information (telephone number and race);
- Customers are advised of the penalty for furnishing false information and are asked to sign a declaration that the information they have provided is true and correct to the best of their knowledge;
- Customers are provided a receipt indicating pertinent information about their voter registration application, including the date on which they applied at the photo license center. The receipt instructs customers to contact their county voter registration office if they do not receive a voter identification card within two weeks.

The completed applications are transmitted electronically by PennDOT's contracted vendor to the Department which, in turn, forwards the applications to individual county voter registration offices via the SURE system. For more detail on applications received from PennDOT license centers, please refer to Appendix E.

Online Voter Registration

The Pennsylvania Online Voter Registration (OVR) Application was deployed on August 27, 2015. The OVR application provides residents of Pennsylvania with the opportunity to register to vote or change an existing voter registration online and electronically submit voter registration data to their county voter registration office for processing. In order to ensure the successful roll out of online voter registration, the Department actively engaged election stakeholders including county election directors, the elections advocacy community, and Pennsylvania citizens. In an effort to ensure that the final product would be universally useable, DOS also engaged the Center for Civic Design to review the text and the logical flow of information. The Center also field tested the application in an urban and a rural community. This highly interactive development process resulted in a better product overall and one that has been embraced by Pennsylvania voters in overwhelming numbers as seen in usage numbers.

During the 2021 calendar year, approximately 186,642 voter registration applications were submitted through the OVR application on the Department's website, including 57,285 new applications. During this same period, a total of 117,207 new paper applications were submitted to county voter registration offices. Since inception, OVR, has accounted for more than 2.89 million applications submitted online through the end of 2021.

Additionally, a relatively new feature to the online voter registration application is the ability to request a mail-in ballot while registering to vote. A separate application will be submitted during the registration process to vote by a mail-in ballot if the applicant chooses to submit the request simultaneously. The Department released this feature in 2020 to further streamline election operations and provide voters additional safe and secure opportunities to vote during the pandemic.


Web Application Programming Interface(Web API)

A Web Application Programming Interface (Web API) was created for individuals and organizations that wish to develop a website to gather voter registration application data during voter registration drives. The Web API application contains information these organizations need to submit voter registration applications in an electronic format versus submitting paper applications. Entities that are granted access to use the API do not have direct access to the SURE system. This tool also interacts with PennDOT to capture signatures from valid driver's licenses and sends the Pending Missing Signature correspondence, as necessary. A rigorous certification process managed by the Department of State ensures the individuals or organizations wishing to use the Web API tool meet DOS-identified testing and security standards prior to approving their Web API account. Like online voter registration, signatures may be uploaded through the Web API interface or a request to receive a mail-in ballot may be submitted as a separate application in

addition to the voter registration application.


Comparison of Voter Registration Methods

The chart below depicts a general comparison of total applications submitted through OVR, OVR Web API, which is a subset of online voter registration, and paper applications. In addition to method of registration, these statistics are also broken down by month to highlight volume throughout the election cycle. This data will not reconcile with the total OVR registrations processed in the VR system because it represents voter activity through OVR. It does not represent the final disposition of the applications. For example, a registrant may submit duplicate applications that are declined after processing.



Demographics of Online Voter Registration

The graph below illustrates a summary breakdown of OVR usage statistics by age group. It provides a general idea of who uses the online service to register to vote or update their voter registration.



Voter Hall of Fame

The Pennsylvania Voter Hall of Fame program is administered by the Department of State, Bureau of Elections and Notaries. The program was established to promote awareness and to encourage all Pennsylvanians to exercise their right to vote. The Voter Hall of Fame publicly honors Pennsylvanians who have voted in at least 50 consecutive November elections. The inductees serve as ambassadors in their communities – leading by example and encouraging participation in the electoral process. In 2021, the Department inducted 169 citizens from nine (9) counties into the Pennsylvania Voter Hall of Fame, despite the COVID-19 pandemic. The 169 new members bring total membership to 24,004, with the membership spanning all 67 counties throughout the Commonwealth. As an ongoing recognition, the Department maintains a display on the third floor of the North Office Building in Harrisburg.

Statewide Uniform Registry of Electors (SURE)

Statewide Uniform Registry of Electors (SURE) is Department's centralized voter registration and election management system, which ensures the accuracy and integrity of the Commonwealth's voter registration records maintained by the election authorities in Pennsylvania's 67 counties. The SURE system is a platform that supports the critical functions of the Commonwealth's elections — from determining voter eligibility to maintaining precinct data to producing poll books. A centralized, uniform registry that is accessible to all county offices greatly enhances the overall accuracy and integrity of the voter registration rolls and the resulting quality of voter services.

SURE Voter Registration (SURE VR)

The SURE VR application is used by counties to process and maintain voter registration records and to perform a number of election-related tasks, including the management of vote history, absentee ballots, poll books, election-related reports, and voter registration correspondence to voters.

SURE Portals

Public Portal

Voters can access the SURE Public Portal through the Department of State website, where they can register to vote online, check their voter registration status, locate their polling place, request an absentee or mail in ballot, and research the status of their absentee or mail in ballot.

County Portal

The SURE County Portal provides counties with voter search, provisional ballot processing/certification, and other basic capabilities through a standard web browser rather than the specialized equipment required to access SURE VR. Counties can use the portal for seasonal and temporary staff who may need to access basic SURE functionality during an election or other busy period. Additionally, counties use the portal to upload election results, certify election results, and certify voter registration statistics.

Agency Portal

The agency portal is used by Department of State personnel to maintain elections and campaign finance data. The Department uses the portal to maintain and retrieve the archive of historic election results by precinct and county, manage nomination petitions, and manage campaign finance records.

WebAPI

A Web Application Programming Interface (Web API) was created for individuals and organizations that wish to develop a website to gather voter registration application data during voter registration drives. The Web API application contains information these organizations need to submit voter registration applications in an electronic format versus submitting paper applications. Entities that are granted access to use the API do not have direct access to the SURE system. This tool also interacts with PennDOT to capture signatures from valid driver's licenses and sends the Pending Missing Signature correspondence, as necessary. A rigorous certification process managed by the Department of State ensures the individuals or organizations wishing to use the Web API tool meet DOS-identified testing and security standards prior to approving their Web API account.
