IN THE MATTER OF: HOMELESS OUTREACH OF CRAWFORD COUNTY

ORDER

AND NOW, THIS 5TH DAY OF MARCH 2012, THE SECRETARY OF THE COMMONWEALTH, HAVING FOUND THAT HOMELESS OUTREACH OF CRAWFORD COUNTY, PO BOX 175, MEADVILLE, PA 16335, IS NOT REGISTERED WITH THE DEPARTMENT'S BUREAU OF CHARITABLE ORGANIZATIONS, HAS FAILED TO RESPOND TO THE BUREAU'S REQUEST FOR INFORMATION AND HAS SOLICITED CONTRIBUTIONS IN PENNSYLVANIA WHILE IT WAS NOT REGISTERED; IN ACCORDANCE WITH THE PENNSYLVANIA SOLICITATION OF FUNDS FOR CHARITABLE PURPOSES ACT, 10 P.S. § 162.1 *ET SEQ.*, HEREBY ORDERS HOMELESS OUTREACH OF CRAWFORD COUNTY TO CEASE AND DESIST FROM SOLICITING CONTRIBUTIONS IN PENNSYLVANIA UNTIL SUCH TIME AS HOMELESS OUTREACH OF CRAWFORD COUNTY HAS DULY REGISTERED WITH THE BUREAU OR PROVIDED INFORMATION THAT IT IS EXCLUDED OR EXEMPT FROM REGISTRATION. THIS ORDER SHALL TAKE EFFECT IMMEDIATELY. ADDITIONALLY, HOMELESS OUTREACH OF CRAWFORD COUNTY MAY BE SUBJECT TO ADMINISTRATIVE FINES OF UP TO \$1,000 PER VIOLATION AND \$100 FOR EACH DAY THE VIOLATION CONTINUES. THIS ORDER SHALL TAKE EFFECT IMMEDIATELY.
