ORDER

AND NOW, THIS 5th DAY OF JUNE, 2014, THE SECRETARY OF THE COMMONWEALTH, HAVING FOUND THAT CHAMPION ENTERPRISES, 416 SPRINGDALE DRIVE, SUITE 33, PITTSBURGH, PA 15235, IS NOT REGISTERED WITH THE DEPARTMENT'S BUREAU OF CHARITABLE ORGANIZATIONS, THAT CHAMPION ENTERPRISES HAS FAILED TO PROVIDE THE BUREAU WITH ALL REQUESTED INFORMATION, AND HAS SOLICITED CONTRIBUTIONS IN PENNSYLVANIA WHILE IT WAS NOT REGISTERED; IN ACCORDANCE WITH THE PENNSYLVANIA SOLICITATION OF FUNDS FOR CHARITABLE PURPOSES ACT, 10 P.S. § 162.1, *ET SEQ.*, HEREBY ORDERS CHAMPION ENTERPRISES TO CEASE AND DESIST FROM SOLICITING CONTRIBUTIONS IN PENNSYLVANIA UNTIL SUCH TIME AS CHAMPION ENTERPRISES PROVIDES THE BUREAU WITH ALL PREVIOUSLY REQUESTED INFORMATION AND CHAMPION ENTERPRISES DULY REGISTERS OR PROVIDES INFORMATION THAT IT IS EXCLUDED OR EXEMPT FROM REGISTRATION. ADDITIONALLY, CHAMPION ENTERPRISES MAY BE SUBJECT TO ADMINISTRATIVE FINES OF UP TO \$1,000 PER VIOLATION AND \$100 FOR EACH DAY THE VIOLATION CONTINUES. THIS ORDER SHALL TAKE EFFECT IMMEDIATELY.
