**IN THE MATTER OF: FIGHTING FOR THE BULLYS PIT BULL RESCUE**

**ORDER**

AND NOW, THIS 7<sup>TH</sup> DAY OF MAY, 2014, THE SECRETARY OF THE COMMONWEALTH, HAVING FOUND THAT FIGHTING FOR THE BULLYS PIT BULL RESCUE, 306 NICHOLS STREET, POTTSVILLE, PA 17901, IS NOT REGISTERED WITH THE DEPARTMENT'S BUREAU OF CHARITABLE ORGANIZATIONS, THAT FIGHTING FOR THE BULLYS PIT BULL RESCUE HAS FAILED TO PROVIDE THE BUREAU WITH ALL REQUESTED INFORMATION, AND HAS SOLICITED CONTRIBUTIONS IN PENNSYLVANIA WHILE IT WAS NOT REGISTERED; IN ACCORDANCE WITH THE PENNSYLVANIA SOLICITATION OF FUNDS FOR CHARITABLE PURPOSES ACT, 10 P.S. § 162.1, *ET SEQ.*, HEREBY ORDERS FIGHTING FOR THE BULLYS PIT BULL RESCUE TO CEASE AND DESIST FROM SOLICITING CONTRIBUTIONS IN PENNSYLVANIA UNTIL SUCH TIME AS FIGHTING FOR THE BULLYS PIT BULL RESCUE PROVIDES THE BUREAU WITH ALL PREVIOUSLY REQUESTED INFORMATION AND FIGHTING FOR THE BULLYS PIT BULL RESCUE DULY REGISTERS OR PROVIDES INFORMATION THAT IT IS EXCLUDED OR EXEMPT FROM REGISTRATION. ADDITIONALLY, FIGHTING FOR THE BULLYS PIT BULL RESCUE MAY BE SUBJECT TO ADMINISTRATIVE FINES OF UP TO \$1,000 PER VIOLATION AND \$100 FOR EACH DAY THE VIOLATION CONTINUES. THIS ORDER SHALL TAKE EFFECT IMMEDIATELY.
