ORDER

AND NOW, THIS 22ND DAY OF AUGUST 2012, THE SECRETARY OF THE COMMONWEALTH, HAVING FOUND THAT PEOPLE'S CHARITY, 741 CUMBERLAND STREET, LEBANON, PA 17042 AND 184 EDIE ROAD, SARATOGA SPRINGS, NY 12866 IS NOT REGISTERED WITH THE DEPARTMENT'S BUREAU OF CHARITABLE ORGANIZATIONS, HAS FAILED TO RESPOND TO THE BUREAU'S REQUEST FOR INFORMATION AND HAS SOLICITED CONTRIBUTIONS IN PENNSYLVANIA WHILE IT WAS NOT REGISTERED; IN ACCORDANCE WITH THE PENNSYLVANIA SOLICITATION OF FUNDS FOR CHARITABLE PURPOSES ACT, 10 P.S. § 162.1 *ET SEQ.*, HEREBY ORDERS PEOPLE'S CHARITY TO CEASE AND DESIST FROM SOLICITING CONTRIBUTIONS IN PENNSYLVANIA UNTIL SUCH TIME AS PEOPLE'S CHARITY HAS DULY REGISTERED WITH THE BUREAU OR PROVIDED INFORMATION THAT IT IS EXCLUDED OR EXEMPT FROM REGISTRATION. THIS ORDER SHALL TAKE EFFECT IMMEDIATELY. ADDITIONALLY, PEOPLE'S CHARITY MAY BE SUBJECT TO ADMINISTRATIVE FINES OF UP TO \$1,000 PER VIOLATION AND \$100 FOR EACH DAY THE VIOLATION CONTINUES. THIS ORDER SHALL TAKE EFFECT IMMEDIATELY.
