**IN THE MATTER OF: KYLE JOHN LESHER MEMORIAL FUND**

**ORDER**

AND NOW, THIS 25<sup>TH</sup> DAY OF SEPTEMBER, 2012, THE SECRETARY OF THE COMMONWEALTH, HAVING FOUND THAT THE **KYLE JOHN LESHER MEMORIAL FUND** 425 PENNSYLVANIA AVENUE, READING, PA 19605, IS NOT REGISTERED WITH THE DEPARTMENT'S BUREAU OF CHARITABLE ORGANIZATIONS, THAT THE **KYLE JOHN LESHER MEMORIAL FUND** HAS FAILED TO PROVIDE THE BUREAU WITH ALL REQUESTED INFORMATION, AND HAS SOLICITED CONTRIBUTIONS IN PENNSYLVANIA WHILE IT WAS NOT REGISTERED; IN ACCORDANCE WITH THE PENNSYLVANIA SOLICITATION OF FUNDS FOR CHARITABLE PURPOSES ACT, 10 P.S. § 162.1, *ET SEQ.*, HEREBY ORDERS THE **KYLE JOHN LESHER MEMORIAL FUND** TO CEASE AND DESIST FROM SOLICITING CONTRIBUTIONS IN PENNSYLVANIA UNTIL SUCH TIME AS THE **KYLE JOHN LESHER MEMORIAL FUND** PROVIDES THE BUREAU WITH ALL PREVIOUSLY REQUESTED INFORMATION AND THE **KYLE JOHN LESHER MEMORIAL FUND** DULY REGISTERS OR PROVIDES INFORMATION THAT IT IS EXCLUDED OR EXEMPT FROM REGISTRATION. ADDITIONALLY, THE **KYLE JOHN LESHER MEMORIAL FUND** MAY BE SUBJECT TO ADMINISTRATIVE FINES OF UP TO \$1,000 PER VIOLATION AND \$100 FOR EACH DAY THE VIOLATION CONTINUES. THIS ORDER SHALL TAKE EFFECT IMMEDIATELY.
