**ORDER**

AND NOW, THIS 28<sup>TH</sup> DAY OF AUGUST, 2014, THE SECRETARY OF THE COMMONWEALTH, HAVING FOUND THAT **ERIE HEMOPHILIA FOUNDATION**, P.O. BOX 3677, ERIE, PA 16508, IS NOT REGISTERED WITH THE DEPARTMENT'S BUREAU OF CORPORATIONS AND CHARITABLE ORGANIZATIONS, THAT **ERIE HEMOPHILIA FOUNDATION** HAS FAILED TO PROVIDE THE BUREAU WITH ALL REQUESTED INFORMATION, AND THAT **ERIE HEMOPHILIA FOUNDATION** HAS SOLICITED CONTRIBUTIONS IN PENNSYLVANIA WHILE IT WAS NOT REGISTERED; IN ACCORDANCE WITH THE PENNSYLVANIA SOLICITATION OF FUNDS FOR CHARITABLE PURPOSES ACT, 10 P.S. § 162.1, *ET SEQ.*, HEREBY ORDERS **ERIE HEMOPHILIA FOUNDATION** TO CEASE AND DESIST FROM SOLICITING CONTRIBUTIONS IN PENNSYLVANIA UNTIL SUCH TIME AS **ERIE HEMOPHILIA FOUNDATION** RESPONDS TO THE BUREAU AND DULY REGISTERS OR PROVIDES INFORMATION THAT IT IS NOT REQUIRED TO REGISTER. ADDITIONALLY, **ERIE HEMOPHILIA FOUNDATION** MAY BE SUBJECT TO ADMINISTRATIVE FINES OF UP TO \$1,000 PER VIOLATION AND \$100 FOR EACH DAY THE VIOLATION CONTINUES. THIS ORDER SHALL TAKE EFFECT IMMEDIATELY.
