IN THE MATTER OF: **BROTHERHOOD OF CHRISTIANITY AND TROY LEITNER**

ORDER

AND NOW, THIS 11TH DAY OF OCTOBER, 2012, THE SECRETARY OF THE COMMONWEALTH, HAVING FOUND THAT **BROTHERHOOD OF CHRISTIANITY AND TROY LEITNER**, 1151 LUZERNE STREET, SCRANTON, PA 18504, ARE NOT REGISTERED WITH THE DEPARTMENT'S BUREAU OF CHARITABLE ORGANIZATIONS, THAT **BROTHERHOOD OF CHRISTIANITY AND TROY LEITNER** HAVE FAILED TO KEEP TRUE FISCAL RECORDS, FAILED TO DEPOSIT CONTRIBUTIONS IN AN ACCOUNT IN THE NAME OF **BROTHERHOOD OF CHRISTIANITY** AND UNDER ITS SOLE CONTROL, AND HAVE SOLICITED CONTRIBUTIONS IN PENNSYLVANIA WHILE **BROTHERHOOD OF CHRISTIANITY** WAS NOT REGISTERED; IN ACCORDANCE WITH THE PENNSYLVANIA SOLICITATION OF FUNDS FOR CHARITABLE PURPOSES ACT, 10 P.S. § 162.1, *ET SEQ.*, HEREBY ORDERS **BROTHERHOOD OF CHRISTIANITY AND TROY LEITNER** TO CEASE AND DESIST FROM SOLICITING CONTRIBUTIONS IN PENNSYLVANIA UNTIL SUCH TIME AS **BROTHERHOOD OF CHRISTIANITY AND TROY LEITNER** COME INTO COMPLIANCE WITH ALL PROVISIONS OF THE ACT AND **BROTHERHOOD OF CHRISTIANITY** DULY REGISTERS OR PROVIDES INFORMATION THAT IT IS EXCLUDED OR EXEMPT FROM REGISTRATION. ADDITIONALLY, **BROTHERHOOD OF CHRISTIANITY AND TROY LEITNER** MAY BE SUBJECT TO ADMINISTRATIVE FINES OF UP TO \$1,000 PER VIOLATION AND \$100 FOR EACH DAY THE VIOLATION CONTINUES. THIS ORDER SHALL TAKE EFFECT IMMEDIATELY.
