IN THE MATTER OF: **COMPANIMALS PET RESCUE, INC**

ORDER

AND NOW, THIS 24TH DAY OF OCTOBER, 2013, THE SECRETARY OF THE COMMONWEALTH, HAVING FOUND THAT THE COMPANIMALS PET RESCUE, INC, 1497 Flint Hill Road, Landenberg, PA 19350, IS NOT REGISTERED WITH THE DEPARTMENT'S BUREAU OF CHARITABLE ORGANIZATIONS, THAT THE COMPANIMALS PET RESCUE, INC HAS FAILED TO PROVIDE THE BUREAU WITH ALL REQUESTED INFORMATION, AND HAS SOLICITED CONTRIBUTIONS IN PENNSYLVANIA WHILE IT WAS NOT REGISTERED; IN ACCORDANCE WITH THE PENNSYLVANIA SOLICITATION OF FUNDS FOR CHARITABLE PURPOSES ACT, 10 P.S. § 162.1, *ET SEQ.*, HEREBY ORDERS THE COMPANIMALS PET RESCUE, INC TO CEASE AND DESIST FROM SOLICITING CONTRIBUTIONS IN PENNSYLVANIA UNTIL SUCH TIME AS THE COMPANIMALS PET RESCUE, INC PROVIDES THE BUREAU WITH ALL PREVIOUSLY REQUESTED INFORMATION AND THE COMPANIMALS PET RESCUE, INC DULY REGISTERS OR PROVIDES INFORMATION THAT IT IS EXCLUDED OR EXEMPT FROM REGISTRATION. ADDITIONALLY, THE COMPANIMALS PET RESCUE, INC MAY BE SUBJECT TO ADMINISTRATIVE FINES OF UP TO \$1,000 PER VIOLATION AND \$100 FOR EACH DAY THE VIOLATION CONTINUES. THIS ORDER SHALL TAKE EFFECT IMMEDIATELY.
