CEASE AND DESIST ORDER

AND NOW, THIS 25th DAY OF APRIL, 2017 THE SECRETARY OF THE COMMONWEALTH, HAVING FOUND THAT ANEW COMMUNITY INSTITUTE, 46 GRAPE STREET, PITTSBURGH, PA 15210, IS NOT REGISTERED WITH THE DEPARTMENT'S BUREAU OF CORPORATIONS AND CHARITABLE ORGANIZATIONS, THAT ANEW COMMUNITY INSTITUTE HAS FAILED TO PROVIDE THE BUREAU WITH ALL REQUESTED INFORMATION, AND HAS SOLICITED CONTRIBUTIONS IN PENNSYLVANIA WHILE IT WAS NOT REGISTERED; IN ACCORDANCE WITH THE PENNSYLVANIA SOLICITATION OF FUNDS FOR CHARITABLE PURPOSES ACT, 10 P.S. § 162.1, *ET SEQ.*, HEREBY ORDERS ANEW COMMUNITY INSTITUTE TO CEASE AND DESIST FROM SOLICITING CONTRIBUTIONS IN PENNSYLVANIA UNTIL SUCH TIME AS ANEW COMMUNITY INSTITUTE PROVIDES THE BUREAU WITH ALL PREVIOUSLY REQUESTED INFORMATION AND ANEW COMMUNITY INSTITUTE DULY REGISTERS OR PROVIDES INFORMATION THAT IT IS EXCLUDED OR EXEMPT FROM REGISTRATION. ADDITIONALLY, ANEW COMMUNITY INSTITUTE MAY BE SUBJECT TO ADMINISTRATIVE FINES OF UP TO \$1,000.00 PER VIOLATION AND \$100.00 FOR EACH DAY THE VIOLATION CONTINUES.

THIS ORDER SHALL TAKE EFFECT IMMEDIATELY.
