CEASE AND DESIST ORDER

AND NOW, THIS 30TH DAY OF SEPTEMBER, 2016, THE SECRETARY OF THE COMMONWEALTH, HAVING FOUND THAT CAMP FIRE NATIONAL HEADQUARTERS, 1801 MAIN STREET, SUITE 200, KANSAS CITY, MO 64108, IS NOT REGISTERED WITH THE DEPARTMENT OF STATE'S BUREAU OF CORPORATIONS AND CHARITABLE ORGANIZATIONS, THAT CAMP FIRE NATIONAL HEADQUARTERS HAS SOLICITED CONTRIBUTIONS IN PENNSYLVANIA WHILE NOT REGISTERED; IN ACCORDANCE WITH THE PENNSYLVANIA SOLICITATION OF FUNDS FOR CHARITABLE PURPOSES ACT, 10 P.S. § 162.1 *ET SEQ.*, HEARBY ORDERS CAMP FIRE NATIONAL HEADQUARTERS TO CEASE AND DESIST FROM SOLICITING CONTRIBUTIONS IN PENNSYLVANIA UNTIL SUCH TIME AS IT DULY REGISTERS OR PROVIDES INFORMATION THAT IT IS EXCLUDED OR EXEMPT FROM REGISTRATION. ADDITIONALLY, CAMP FIRE NATIONAL HEADQUARTERS MAY BE SUBJECT TO ADMINISTRATIVE FINES OF UP TO \$1,000 PER VIOLATION OF THE ACT AND \$100 FOR EACH DAY THE VIOLATION CONTINUES. THIS ORDER SHALL TAKE EFFECT IMMEDIATELY.
