IN THE MATTER OF: **EQUINE ANGELS RESCUE AND PAMELA VIVIRITO**

ORDER

AND NOW, THIS 8TH DAY OF **FEBRUARY, 2016**, THE SECRETARY OF THE COMMONWEALTH, HAVING FOUND THAT **EQUINE ANGELS RESCUE AND PAMELA VIVIRITO**, 372 STEINER BRIDGE ROAD, VALENCIA, PA 16059, ARE NOT REGISTERED WITH THE DEPARTMENT'S BUREAU OF CHARITABLE ORGANIZATIONS, HAS FAILED TO RESPOND TO THE BUREAU'S REQUEST FOR REGISTRATION REQUIREMENTS, AND HAS SOLICITED CONTRIBUTIONS IN PENNSYLVANIA WHILE NOT REGISTERED; IN ACCORDANCE WITH THE PENNSYLVANIA SOLICITATION OF FUNDS FOR CHARITABLE PURPOSES ACT, 10 P.S. § 162.1, *ET SEQ.*, HEREBY ORDERS **EQUINE ANGELS RESCUE AND PAMELA VIVIRITO** TO CEASE AND DESIST FROM SOLICITING CONTRIBUTIONS IN PENNSYLVANIA UNTIL SUCH TIME AS **EQUINE ANGELS RESCUE AND PAMELA VIVIRITO** PROVIDES THE BUREAU WITH ALL PREVIOUSLY REQUESTED INFORMATION AND **EQUINE ANGELS RESCUE AND PAMELA VIVIRITO** DULY REGISTERS OR PROVIDES INFORMATION THAT THEY ARE EXCLUDED OR EXEMPT FROM REGISTRATION. ADDITIONALLY, **EQUINE ANGELS RESCUE AND PAMELA VIVIRITO** MAY BE SUBJECT TO ADMINISTRATIVE FINES OF UP TO \$1,000 PER VIOLATION AND \$100 FOR EACH DAY THE VIOLATION CONTINUES. THIS ORDER SHALL TAKE EFFECT IMMEDIATELY.
