AND NOW, THIS 3RD DAY OF MAY 2022, THE ACTING SECRETARY OF THE COMMONWEALTH, HAVING FOUND **GREATER PENNSYLVANIA MILITARY PRESERVATION ASSOCIATION, L.L.C. AND/OR THOMAS GRAY, P.O. BOX 3202, ALTOONA, PA 16603** IS NOT REGISTERED WITH THE DEPARTMENT OF STATE'S BUREAU OF CORPORATIONS AND CHARITABLE ORGANIZATIONS AND/OR HAS FAILED TO SUBMIT ALL REQUESTED DOCUMENTATION TO THE DEPARTMENT OF STATE, BUREAU OF CORPORATIONS AND CHARITABLE ORGANIZATIONS OR THE BUREAU OF ENFORCEMENT AND INVESTIGATION; IN ACCORDANCE WITH THE PENNSYLVANIA SOLICITATION OF FUNDS FOR CHARITABLE PURPOSES ACT, 10 P.S. § 162.1 *ET SEQ.*, **HEREBY ORDERS GREATER PENNSYLVANIA MILITARY PRESERVATION ASSOCIATION, L.L.C. AND/OR THOMAS GRAY** TO IMMEDIATELY **CEASE AND DESIST** FROM SOLICITING CONTRIBUTIONS ON BEHALF OF OR AS A CHARITABLE ORGANIZATION, OR CONDUCTING ANY SERVICES OF A PROFESSIONAL FUNDRAISING COUNSEL OR PROFESSIONAL SOLICITOR IN PENNSYLVANIA UNTIL SUCH TIME AS IT PROVIDES THE DEPARTMENT OF STATE, BUREAU OF CORPORATIONS AND CHARITABLE ORGANIZATIONS WITH ALL PREVIOUSLY REQUESTED INFORMATION AND DULY REGISTERS OR PROVIDES INFORMATION THAT IT IS EXCLUDED OR EXEMPT FROM REGISTRATION, AS DETERMINED BY THE DEPARTMENT OF STATE, BUREAU OF CORPORATIONS AND CHARITABLE ORGANIZATIONS. **THIS INCLUDES CEASING ALL INTERNET SOLICITATIONS VIA A "DONATE BUTTON" ON A WEBSITE.** RESPONDENT MAY ALSO BE SUBJECT TO FORMAL ADMINISTRATIVE ACTION, WHICH COULD RESULT IN THE IMPOSITION OF ADMINISTRATIVE FINES OF UP TO ONE THOUSAND DOLLARS (\$1,000.00) PER VIOLATION OF THE ACT PLUS AN ADDITIONAL PENALTY OF ONE HUNDRED DOLLARS (\$100.00) PER DAY FOR EACH DAY THE VIOLATION CONTINUES.

THIS ORDER SHALL TAKE EFFECT IMMEDIATELY.
