AND NOW, THIS 24TH DAY OF MARCH, 2016 THE SECRETARY OF THE COMMONWEALTH, HAVING FOUND THAT **LYNDA L. CAMPANA**, 18 WEST MAPLE STREET, WILKES-BARRE PA 18702, IS NOT REGISTERED WITH THE DEPARTMENT'S BUREAU OF CHARITABLE ORGANIZATIONS, THAT **LYNDA L. CAMPANA** HAS FAILED TO PROVIDE THE BUREAU WITH ALL REQUESTED INFORMATION, AND HAS SOLICITED CONTRIBUTIONS IN PENNSYLVANIA; IN ACCORDANCE WITH THE PENNSYLVANIA SOLICITATION OF FUNDS FOR CHARITABLE PURPOSES ACT, 10 P.S. § 162.1, *ET SEQ.*, HEREBY ORDERS **LYNDA L. CAMPANA** TO CEASE AND DESIST FROM SOLICITING CONTRIBUTIONS IN PENNSYLVANIA UNTIL SUCH TIME AS **LYNDA L. CAMPANA** PROVIDES THE BUREAU WITH ALL PREVIOUSLY REQUESTED INFORMATION. ADDITIONALLY **LYNDA L. CAMPANA** MAY BE SUBJECT TO ADMINISTRATIVE FINES OF UP TO \$1,000 PER VIOLATION AND \$100 FOR EACH DAY THE VIOLATION CONTINUES. THIS ORDER SHALL TAKE EFFECT IMMEDIATELY.
