CEASE AND DESIST ORDER

AND NOW, THIS 13th DAY OF APRIL, 2017 THE SECRETARY OF THE COMMONWEALTH, HAVING FOUND THAT PITTSBURGH FAMILY DEVELOPMENT, 708 TALBOT AVENUE, BRADDOCK, PA 15104 IS NOT REGISTERED WITH THE DEPARTMENT'S BUREAU OF CORPORATIONS AND CHARITABLE ORGANIZATIONS, THAT PITTSBURGH FAMILY DEVELOPMENT HAS FAILED TO PROVIDE THE BUREAU WITH ALL REQUESTED INFORMATION, AND HAS SOLICITED CONTRIBUTIONS IN PENNSYLVANIA WHILE IT WAS NOT REGISTERED; IN ACCORDANCE WITH THE PENNSYLVANIA SOLICITATION OF FUNDS FOR CHARITABLE PURPOSES ACT, 10 P.S. § 162.1, *ET SEQ.*, HEREBY ORDERS PITTSBURGH FAMILY DEVELOPMENT TO CEASE AND DESIST FROM SOLICITING CONTRIBUTIONS IN PENNSYLVANIA UNTIL SUCH TIME AS PITTSBURGH FAMILY DEVELOPMENT PROVIDES THE BUREAU WITH ALL PREVIOUSLY REQUESTED INFORMATION AND PITTSBURGH FAMILY DEVELOPMENT DULY REGISTERS OR PROVIDES INFORMATION THAT IT IS EXCLUDED OR EXEMPT FROM REGISTRATION. ADDITIONALLY, PITTSBURGH FAMILY DEVELOPMENT MAY BE SUBJECT TO ADMINISTRATIVE FINES OF UP TO \$1,000.00 PER VIOLATION AND \$100.00 FOR EACH DAY THE VIOLATION CONTINUES. THIS ORDER SHALL TAKE EFFECT IMMEDIATELY.
