AND NOW, THIS 6th DAY OF February, 2019, THE ACTING SECRETARY OF THE COMMONWEALTH, HAVING FOUND THAT PITTSBURGH OUTREACH PROGRAM AND SPIRITUAL DEVOTIONAL OUTREACH RECOVERY PROGRAM AND TYRONE BURRELL A/K/A TYRONE "T-BIRD" BURRELL, 180 SPRING AVENUE, PITTSBURGH, PA 15202 AND 450 HAYS AVENUE, PITTSBURGH, PA 15210 ARE NOT REGISTERED WITH THE DEPARTMENT OF STATE'S BUREAU OF CORPORATIONS AND CHARITABLE ORGANIZATIONS AND/OR HAVE FAILED TO SUBMIT REQUESTED DOCUMENTATION TO THE DEPARTMENT OF STATE, BUREAU OF CORPORATIONS AND CHARITABLE ORGANIZATIONS OR THE BUREAU OF ENFORCEMENT AND INVESTIGATION; IN ACCORDANCE WITH THE PENNSYLVANIA SOLICITATION OF FUNDS FOR CHARITABLE PURPOSES ACT, 10 P.S. § 162.1 ET SEQ., **HEREBY ORDERS** PITTSBURGH OUTREACH PROGRAM AND SPIRITUAL DEVOTIONAL OUTREACH RECOVERY PROGRAM AND TYRONE BURRELL A/K/A TYRONE "T-BIRD" BURRELL, TO IMMEDIATELY **CEASE AND DESIST** FROM SOLICITING CONTRIBUTIONS OR PERFORMING AS A CHARITABLE ORGANIZATION, OR CONDUCTING ANY SERVICES OF A PROFESSIONAL FUNDRAISING COUNSEL OR PROFESSIONAL SOLICITOR IN PENNSYLVANIA UNTIL SUCH TIME AS IT PROVIDES THE DEPARTMENT OF STATE, BUREAU OF CORPORATIONS AND CHARITABLE ORGANIZATIONS WITH ALL PREVIOUSLY REQUESTED INFORMATION AND DULY REGISTERS OR PROVIDES INFORMATION THAT IT IS EXCLUDED OR EXEMPT FROM REGISTRATION, AS DETERMINED BY THE DEPARTMENT OF STATE, BUREAU OF CORPORATIONS AND CHARITABLE ORGANIZATIONS.

RESPONDENT MAY ALSO BE SUBJECT TO FORMAL ADMINISTRATIVE ACTION, WHICH COULD RESULT IN THE IMPOSITION OF ADMINISTRATIVE FINES OF UP TO ONE THOUSAND DOLLARS (\$1,000.00) PER VIOLATION OF THE ACT PLUS AN ADDITIONAL PENALTY OF ONE HUNDRED DOLLARS (\$100.00) PER DAY FOR EACH DAY THE VIOLATION CONTINUES.

THIS ORDER SHALL TAKE EFFECT IMMEDIATELY.
