**IN THE MATTER OF: RIDE FOR HANNAH AND WILLIAM REIDER AND CHRISTA REIDER**

**ORDER**

AND NOW, THIS 2ND DAY OF DECEMBER 2011, THE SECRETARY OF THE COMMONWEALTH, HAVING FOUND THAT RIDE FOR HANNAH AND WILLIAM REIDER AND CHRISTA REIDER, 1778 UPPER SMITH GAP ROAD, SAYLORSBURG, PA 18353, ARE NOT REGISTERED WITH THE DEPARTMENT'S BUREAU OF CHARITABLE ORGANIZATIONS, HAVE FAILED TO RESPOND TO THE BUREAU'S REQUEST FOR INFORMATION AND HAVE SOLICITED CONTRIBUTIONS IN PENNSYLVANIA WHILE THEY WERE NOT REGISTERED; IN ACCORDANCE WITH THE PENNSYLVANIA SOLICITATION OF FUNDS FOR CHARITABLE PURPOSES ACT, 10 P.S. § 162.1 *ET SEQ.*, HEREBY ORDERS RIDE FOR HANNAH AND WILLIAM REIDER AND CHRISTA REIDER TO CEASE AND DESIST FROM SOLICITING CONTRIBUTIONS IN PENNSYLVANIA UNTIL SUCH TIME AS RIDE FOR HANNAH AND WILLIAM REIDER AND CHRISTA REIDER HAVE DULY REGISTERED WITH THE BUREAU OR PROVIDED INFORMATION THAT THEY ARE EXCLUDED OR EXEMPT FROM REGISTRATION. THIS ORDER SHALL TAKE EFFECT IMMEDIATELY. ADDITIONALLY, RIDE FOR HANNAH AND WILLIAM REIDER AND CHRISTA REIDER MAY BE SUBJECT TO ADMINISTRATIVE FINES OF UP TO \$1,000 PER VIOLATION AND \$100 FOR EACH DAY THE VIOLATION CONTINUES. THIS ORDER SHALL TAKE EFFECT IMMEDIATELY.
