CEASE AND DESIST ORDER

AND NOW, THIS 16TH DAY OF AUGUST, 2016, THE SECRETARY OF THE COMMONWEALTH, HAVING FOUND THAT **SOUTHWEST GREENSBURG VOLUNTEER FIRE DEPARTMENT**, 401 GUTHRIE STREET, GREENSBURG, PENNSYLVANIA 15601, IS NOT REGISTERED WITH THE DEPARTMENT OF STATE'S BUREAU OF CORPORATIONS AND CHARITABLE ORGANIZATIONS, THAT **SOUTHWEST GREENSBURG VOLUNTEER FIRE DEPARTMENT** HAS FAILED TO PROVIDE THE BUREAU WITH ALL REQUESTED INFORMATION, AND HAS SOLICITED CONTRIBUTIONS IN PENNSYLVANIA WHILE NOT REGISTERED; IN ACCORDANCE WITH THE PENNSYLVANIA SOLICITATION OF FUNDS FOR CHARITABLE PURPOSES ACT, 10 P.S. § 162.1 *ET SEQ.*, HEARBY ORDERS **SOUTHWEST GREENSBURG VOLUNTEER FIRE DEPARTMENT** TO CEASE AND DESIST FROM SOLICITING CONTRIBUTIONS IN PENNSYLVANIA UNTIL SUCH TIME AS IT PROVIDES THE BUREAU WITH ALL PREVIOUSLY REQUESTED INFORMATION AND DULY REGISTERS OR PROVIDES INFORMATION THAT IT IS EXCLUDED OR EXEMPT FROM REGISTRATION. ADDITIONALLY, **SOUTHWEST GREENSBURG VOLUNTEER FIRE DEPARTMENT** MAY BE SUBJECT TO ADMINISTRATIVE FINES OF UP TO \$1,000 PER VIOLATION OF THE ACT AND \$100 FOR EACH DAY THE VIOLATION CONTINUES. **THIS ORDER SHALL TAKE EFFECT IMMEDIATELY.**
