Doors Open Pittsburgh, Pittsburgh, PA, paid a \$3,000.00 administrative fine as the result of soliciting contributions from 2017 to 2020, without the approved registration filed with the Bureau after it received contributions in excess of \$25,000.00 per annum in violation of 10 P.S. § 162.15(a)(1). #### **Washington County**

Center for Coalfield Justice in Washington, PA, paid a \$2,000.00 administrative fine as the result of soliciting contributions from May 16, 2020, through September 22, 2021, without the approved registration filed with the Bureau after it received contributions in excess of \$25,000.00 per annum in violation of 10 P.S. § 162.15(a)(1).
