## Message from the Chairman

I was first appointed to this board on Dec. 9, 1997 to fill an unexpired term, and subsequently reappointed to serve two more full terms. As a board member for almost ten years, and having served as vice chairman for the past several years, I have had the opportunity to work with a number of very dedicated, talented and knowledgeable staff and board members. It was an honor to accept the duties of chairman in Dec. 2006.

This board originally was called the State Board of Social Work Examiners. With the exception of one public member, the board consisted of four licensed social workers. Some things have changed during the past ten years and some have remained the same.

The State Board of Social Workers, Marriage and Family Therapists and Professional Counselors continues to have the same mission: Protect the integrity of the professions and protect the health, safety and welfare of the consumer.

The functions of the board have not changed. They include:

- Passing on the qualifications and fitness of applicants for licenses;
- Adopting and revising rules and regulations; and

- Imposing discipline upon individuals who have been found to be in violation of the Act or lawfully promulgated regulations of the board.

Much of the board's time in the past few years has been devoted to the latter two functions.

With the final passage of regulations dealing with continuing education, it is hoped that there will be many more opportunities for licensees to obtain thirty approved continuing education credits for biennial renewal, and that there will be fewer individuals found with audit exceptions. In the past, only licensed social workers were required to obtain the thirty approved continuing education credits for biennial renewal.

With the change in regulations, all 13,500+ currently active licensees under the jurisdiction of the board will be required to obtain, and if audited, show proof of having completed, the CEU's.

It should also be noted that three of the thirty clock hours must be related to ethical issues. I would encourage all licensees to go to our Web site and familiarize themselves with these regulations and other board updates.

We recently were informed that the board was projected to have a deficit within the next year or two. Don't be too surprised if there is an increase in the biennial renewal fees in 2009.

## Prosecution's Charging Unit Celebrates One-Year Anniversary

Since the charging unit hit the ground running in August 2006, it has saved time and resources for the prosecution department. Under the direction of Peter Marks, executive deputy chief counsel, and C.A.L. Shields, Bureau of Enforcement and Investigation director and a four-term elected district attorney from Schuylkill County, the unit consists of four prosecutors, BEI's director and deputy director.

The unit meets daily to review and analyze complaints and investigations of professional misconduct on behalf of the 27 boards and commissions. The unit makes prosecutorial decisions, including dismissals, reinvestigations, negotiated consent agreements, re-reviews, and recommendations for formal action by trial prosecutors. It allows decision-making at a much earlier time in the process and subjects each case to analysis by at least two or more experienced prosecutors. The result is quicker, better and more efficient decision-making and processing of professional complaints.

The charging unit is a concept that Governor Edward G. Rendell used while he was district attorney of Philadelphia. As district attorney, Governor Rendell used the charging unit to reduce the criminal case backlog in Philly. In fact, most, if not all, of the district attorneys in Pennsylvania use a charging unit of some sort to process criminal complaints and to control the criminal case backlog in their counties. Based on my experience as an intern with the Philly DA's office during that time, I wanted to adapt a charging unit to what we do here at BPOA.

As you see, the charging unit solves two problems: it coordinates the legal office, compliance department and BEI under a single unit; and it brings a legal analysis into the complaint review process as soon as a consumer files a complaint with BPOA.

Keep up the great work streamlining the processes and saving time and resources to better serve the citizens of Pennsylvania.

## Continuing Education Requirement for All Licensees

Licensed social workers and clinical social workers have been required to obtain continuing education for some time. Board regulations now require all licensees (social workers, clinical social workers, marriage and family therapists and professional counselors) to complete 30 clock hours of continuing education every two years in order to renew their licenses.

Beginning with the biennial period March 1, 2007 through Feb. 28, 2009, licensed marriage and family therapists and licensed professional counselors will, for the first time, be required to complete 30 hours of continuing education in order to renew their licenses.

The regulations require licensees to take continuing education in acceptable courses and programs related to the licensee's profession.

For instance, a marriage and family therapist must take continuing education in courses and programs

appropriate for the master's level practitioner and pertain to the practice of marriage and family therapy. Licensed professional counselors must take continuing education in courses and programs appropriate for the master's level practitioner and pertain to the practice of professional counseling.

The regulations require all licensees to obtain at least three of the 30 clock hours in ethical issues. Up to 20 hours of the 30 hours may be completed in home study.

The regulations include a list of preapproved providers of continuing education courses and programs. Many of the professional associations who provide programs are on the list. In addition, providers or individual licensees may seek board approval of a course or program by applying to the board at least 90 days before the date the course or program commences.

## On MFT Supervision

As marriage and family therapist (MFT) clinicians, you are well aware that clinical supervision is a very important part of training and continued learning within the MFT discipline. MFTs are unique with regard to the credential of approved supervisor, which is achieved through the American Association of Marriage and Family Therapists (AAMFT). Supervision is one of the cornerstones of MFT education and ethics, and the field always has promoted and encouraged MFTs to continue learning and expanding clinical skills through supervision. In addition, there is the hope that these same therapists one day will also become approved supervisors.

Never was it more important to the MFT field than it is right now for approved supervisors to recognize their value and importance to the field. Beginning Jan. 1, 2010, at least half of the supervision a MFT receives toward licensing requirements will have to be with an AAMFT-approved supervisor. Currently, one of the options for supervision toward licensing can be with someone who is practicing as an MFT, has taken one MFT supervision course, and has five years experience within the last 10 years.

This will no longer be the case after Jan. 1, 2010. This means that the demand for supervision

with an AAMFT-approved supervisor is going to increase. We currently do not have enough approved supervisors in the state of Pennsylvania. The field needs experienced and seasoned MFTs who are eligible to become approved supervisors to do so in order to assist the newer therapists on their professional journey.

With licensing, the MFT field is growing in Pennsylvania. There is an increased understanding of the discipline of marriage and family therapy, which has led toward more people choosing the MFT discipline as their field of study. Therefore, it is vital to the field that seasoned MFTs be available as supervisors and mentors.

Much is gained through the process of clinical supervision. There is an incredible advantage for newer therapists to have the wisdom and guidance of an approved supervisor as they continue on the path of developing and advancing their clinical skills.

Supervision does not stop when a therapist becomes licensed. It continues as long as the therapist has a need for it and is learning from his mentor and supervisor. It is important for the seasoned MFT who is in the position to become an approved supervisor to consider doing so and share his wisdom with those who are following in their footsteps.
