MESSAGE FROM THE PRESIDENT

I wish to pass along Greetings from the members of the State Architects Licensure Board to all Licensed Architects in the Commonwealth and to the candidates involved in the process of gaining experience for their AXP record and preparing to take the new ARE 5.0 exams for licensure. I am glad to see that firms are benefitting from the current economic conditions through increased project workloads and design professionals are finding opportunities for advancing their careers. At all times it is important to remember the responsibility of the Licensed Architect to protect the Health, Safety, and Welfare of the public through the design of their buildings. During busy times and heavy workloads, facing challenging deadlines can make it difficult to provide the oversight and careful review required of the Architect in Responsible Charge of a project. By placing your seal on the document you are assuming that responsibility and acknowledging you have supervised the development of the document(s).

2019 is a Renewal year for Architects in Pennsylvania. Be sure to respond to your notice for renewing in a timely manner. Performing architectural services on an expired license is the most common violation of our licensure law. You can easily avoid a penalty and the mark it leaves on your professional record by renewing your license before the expiration date. Firm licenses are also required to be renewed at each biennial cycle. If you are no longer practicing in PA, please notify the Board Administrator and identify your license as inactive.

The subject of license renewal provides an opportunity to express the importance of not only keeping your license current but also keeping current with new trends, developing technologies, changing building codes, and many other factors that impact our profession and daily practice. Pennsylvania is one of a very small number of jurisdictions where an Architect's license renewal does not require completing Continuing Education credits. I find this fact embarrassing. As professionals licensed to protect the public it seems reasonable for the public to assume that a current license reflects a commitment to maintaining current professional standards. Continuing Education requirements of many professional license boards serve to address this purpose. For licensees in PA that are AIA members or have active licenses in other jurisdictions, completing continuing education credits is part of their yearly agenda. As a Professional Licensure Board we are hoping Pennsylvania will soon adopt this standard.

The responsibilities of our profession, our license, as well as good business practice cover a wide range of duties. An aspect that is not addressed as often as it deserves is the Ethics of Professional Practice. This responsibility for ethical standards and practice occurs at all levels of our profession. The need for more discussion of this subject was made evident recently with NCARB's disclosure of sanctions imposed on a number of candidates taking the registration exams. The individuals involved were part of a study group that were exchanging information using direct examples from current exams. Candidates taking the ARE sign an agreement that identifies the confidentiality policies required of them. Some ethical standards are obvious and common sense type, other issues that present ethical challenges are not so obvious and deserve discussion. An occasional refresher course of the dilemmas that face our profession is a worthwhile pursuit that might shed light on decisions we make in our practices.

Pennsylvania is one of 55 jurisdictions that comprise the National Council of Architectural Registration Boards (NCARB). 2019 is the 100th Anniversary of NCARB and our Board is proud to be part of the NCARB organization and to serve Pennsylvania's licensed Architects.
