CZ115200 of Broomall, Delaware County, was ordered to pay a civil penalty of \$2,300 because the spa was open for business and neither the owner nor the designated licensee was in charge, did not have the license to operate on the premises of the salon, failed to maintain tools that come into contact with a client in a sanitary condition at all times, failed to have a complete first aid kit, employed an unlicensed individual, practiced nail technology in a grossly incompetent or unethical manner through the use of a metal rasp, failed to keep unused paper towels in a closed towel dispenser, failed to store clean towels in a closed towel cabinet, failed to store dirty towels in a closed container, failed to maintain tools that come into contact with a client in a sanitary condition at all times, and failed to have a cover on an open waste container. Havertown Nail, license no.
