Gifford & Uslin PC, unlicensed of Bensalem, Bucks County, was ordered to pay a civil penalty of \$4,500 because it practiced as a certified public accountancy firm when the firm was not currently licensed and registered under the practice act between April 20, 1990, and March 25, 2009. (01/19/10)

Philip Keith Miller, certificate no. CA022420L of Elizabethtown, Lancaster County, had his certificate of certified public accountant and current license to practice public accounting suspended for two years, effective Jan. 4, 2010, and was assessed a \$5,000 civil penalty based on his guilty plea in state court to five felony counts of possession of child pornography.
