### **Bucks County**

Jacqueline O'Hara of Warminster, Bucks County, was issued a public reprimand and prohibited from assuming any position, whether voluntary or paid, in any charitable organization, which involves the solicitation, collection or expenditure of contributions for violating the Solicitation of Funds for Charitable Purposes Act by causing the Warminster Pioneers Youth Football and Cheerleading Association to apply contributions not consistent with their charitable purpose and breaching fiduciary duties owed to the association. ### **Cambria County**

Christian Rose of Johnstown, Cambria County, was issued a public reprimand, ordered to cease and desist from using the Make-A-Wish Foundation name and logo without written authorization, and prohibited from assuming any position, whether voluntary or paid, in any charitable organization, which involves the solicitation, collection or expenditure of contributions for violating the Solicitation of Funds for Charitable Purposes Act by utilizing the Make-A-Wish Foundation's name without first obtaining written authorization from the organization. ### **Cumberland County**

Sound of America Inc. of Carlisle, Cumberland County, was ordered to pay an administrative fine of \$1,000 for violating the Solicitation of Funds for Charitable Purposes Act by failing to produce requested records or disclose information. (03/08/11)

### **Dauphin County**

Daystar Center for Spiritual Recovery of Harrisburg, Dauphin County, was ordered to pay an administrative fine of \$1,000 for violating the Solicitation of Funds for Charitable Purposes Act by failing to keep true and accurate records. (03/08/11)

### **Philadelphia County**

Judith Hyman of Philadelphia, Philadelphia County, was ordered to pay an administrative fine of \$1,500 for violating the Solicitation of Funds for Charitable Purposes Act by providing professional solicitor services prior to being registered, and by failing to file her contract with a charitable organization with the Bureau of Charitable Organizations prior to rendering professional solicitor services. The Frederick A. Simone, M.D. Foundation Inc. of Philadelphia, Philadelphia County, was ordered to pay an administrative fine of \$5,000 for violating the Solicitation of Funds for Charitable Purposes Act by soliciting charitable contributions in Pennsylvania without being property registered. CTL Associates Inc. of McDonough, Ga., was ordered to pay an administrative fine of \$3,000 for violating the Solicitation of Funds for Charitable Purposes Act by failing to file their contract with a charitable organization with the Bureau of Charitable Organizations prior to rendering professional fundraising counsel services. Insight Tele-Services Inc. of Southfield, Mich., was ordered to pay an administrative fine of \$2,000 for violating the Solicitation of Funds for Charitable Purposes Act by failing to file their contract with a charitable organization with the Bureau of Charitable Organizations prior to rendering professional solicitor services. (03/08/11)

HSP Direct LLP of Herndon, Va., was ordered to pay an administrative fine of \$1,000 for violating the Solicitation of Funds for Charitable Purposes Act by failing to file their contract with a charitable organization with the Bureau of Charitable Organizations prior to rendering professional fundraising counsel services. (03/08/11)

National Relief Charities of Sherman, Texas, was ordered to pay an administrative fine of \$6,000 for violating the Solicitation of Funds for Charitable Purposes Act by making material false statements on applications, statements or reports required to be filed with the Bureau of Charitable Organizations for fiscal years ending Dec. 31, 2006, Dec. 31, 2007 and Dec. 31, 2008. Cancer Federation Inc. of Banning, Calif., was ordered to pay an administrative fine of \$4,000, voluntarily surrender their registration as a charitable organization and cease and desist from soliciting charitable contributions in the commonwealth for five years for violating the Solicitation of Funds for Charitable Purposes Act by making materially false statements on applications, statements or reports for fiscal years ending May 31, 2007 and May 31, 2008, for not keeping true and accurate fiscal records, and for failing to produce records upon request. Donation Line Inc. of Amston, Conn., was ordered to pay an administrative fine of \$7,000 for violating the Solicitation of Funds for Charitable Purposes Act by providing professional solicitor services in Pennsylvania without being properly registered. (03/08/11)

Griswold & Griswold Inc. of Alexandria, Va., was ordered to pay an administrative fine of \$1,000 for violating the Solicitation of Funds for Charitable Purposes Act by failing to file their contract with a charitable organization with the Bureau of Charitable Organizations prior to rendering professional fundraising counsel services. (03/08/11)

Share Group Inc. of Newton, Mass., was ordered to pay an administrative fine of \$4,000 and outstanding administrative fines of \$2,225 for violating the Solicitation of Funds for Charitable Purposes Act by failing to file campaign reports within 90 days after a solicitation campaign or event that was completed, and for failing to pay administrative fines assessed by the Bureau of Charitable Organizations. CY194969 and CL183545 of Reading, Berks County, was ordered to pay a civil penalty of \$300 for failing to maintain the salon in a sanitary condition, failing to maintain tools that come into contact with a client in a sanitary condition at all times, and failing to maintain equipment that comes into contact with a client in a sanitary condition at all times. Da Vi Nails, license no. CY195303 of Bechtelsville, Berks County, was ordered to pay a civil penalty of \$1,000 because it engaged in the practice of booth rental. (03/07/11)

### **Bradford County**

Trans Nailery II, license nos. CY100672L and CZ115166 of Springfield, Bradford County, was ordered to pay a civil penalty of \$800 because it failed to have a complete first aid kit, failed to keep used cloth towels in a closed cabinet or storage container, failed to maintain tools that come into contact with a client in a sanitary condition at all times, and failed to have a timer clock. ### **Bucks County**

Main Street Salon, license no. CB101007L of Silverdale, Bucks County, was ordered to pay a civil penalty of \$500 because it practiced in a grossly incompetent or unethical manner and provided cosmetology services on an expired license. (03/07/11)

### **Chester County**

Trang Thoi Thi Nguyen, t/d/b/a Oriental Nail II, license nos. CY105041L, CZ105963L, CL014420L and CQ110596 of Downingtown, Chester County, was ordered to pay a civil penalty of \$6,500 for committing numerous violations, including the presence of metal rasps inside the nail technology salon. Berwyn Nails, license no. CB109200 of Berwyn, Chester County, was ordered to pay a civil penalty of \$700 because it practiced in a grossly incompetent or unethical manner by failing to have a shampoo tray or basin, a complete first aid kit, a multi-purpose fire extinguisher, and the required number of brushes and combs. Mai X. Nguyen, individually, d/b/a Limited Nail Salon, and Limited Nail Salon, license nos. CY108535 and CL179359 of Downingtown, Chester County, was ordered to pay a civil penalty of \$1,800 and the costs of investigation of \$66.96 because it did not have its owners' current license available and on the premises, practiced nail technology in a grossly incompetent and unethical manner through the use of razor tools, performed waxing services when not licensed to do so, failed to have a first-aid kit, failed to maintain tools that come into contact with a client in a sanitary condition at all times, and used the salon for other purposes by conducting a clothing alteration business within the square footage of salon. ### **Delaware County**

Onde Spalon Inc., license no. CB116892 of Newtown Square, Delaware County, was assessed a civil penalty of \$550 for gross incompetency or unethical practice of a nail salon. (12/21/10)

Castaldi's Salon, license no. CB116517 of Chadds Ford, Delaware County, was ordered to pay a civil penalty of \$500 because it practiced cosmetology in a grossly incompetent or unethical manner through the use of razor tools. (03/07/11)

### **Lackawanna County**

Vu Quach, t/d/b/a Pro Nails, license nos. CZ116595 and CY194981 of Scranton, Lackawanna County, was ordered to pay a civil penalty of \$1,500 because she, while trading and doing business as Pro Nails, practiced in a grossly incompetent or unethical manner through the use of metal foot files. Caroline Cao, unlicensed of Lancaster, Lancaster County, had her application for licensure denied based on her trying to have someone other than she take the examination after she had previously failed the examination. (12/17/10)

CB081823L of Columbia, Lancaster County, was ordered to pay a civil penalty of \$2,200 because it practiced cosmetology in a grossly incompetent or unethical manner; failed to maintain clean towels in a closed container; and failed to maintain tools, instruments, utensils and appliances that come in contact with a client in a sanitary condition at all times. ### **Lehigh County**

Thao T. Le, d/b/a L E Nails, license no. CY102566L of Allentown, Lehigh County, was ordered to pay a civil penalty of \$2,550 because it practiced nail technology in a grossly incompetent or unethical manner through the use of razor scraper tools and failed to have a complete first aid kit. ### **Montgomery County**

Deloris McDonald-Mills, license no. CO203131L of Norristown, Montgomery County, was ordered to pay a civil penalty of \$500 because she practiced cosmetology on a lapsed license. (12/08/10)

Kyung Ok Pae, t/d/b/a Grin Nails, license no. CY192690 of Spring House, Montgomery County, was assessed a civil penalty of \$1,000 for gross incompetency or unethical practice of a nail salon. (12/21/10)

Mi Sun Kim, license nos. CO257508, CY195841 and CZ117388 of Colmar, Montgomery County, was ordered to pay a civil penalty of \$500 for maintaining an unlicensed nail technology and esthetician salon. (03/07/11)

## **Philadelphia County**

CB119223 of Philadelphia, Philadelphia County, had the salon's license revoked and was assessed a civil penalty of \$5,000 for operating a cosmetology salon while the license was under suspension, failing to return the licensure certificates to the board as previously ordered, and failing to pay an outstanding fine. Charise L. Dorsey, license no. CO217067L of Philadelphia, Philadelphia County, was ordered to pay a civil penalty of \$500 because she practiced on an expired license from Jan. 31, 2009, through Oct.9, 2009. (03/07/11)

International Beauty Academy, t/d/b/a International Beauty Academy, license no. CS001502 of Philadelphia, Philadelphia County, was ordered to pay a civil penalty of \$4,500 because it practiced in a grossly incompetent or unethical manner by teaching and permitting microdermabrasion, permanent make-up/tattooing application, and the use of metal rasps in the school, with each metal rasp being a separate violation; teachers' uniforms were not distinguishable from that of the students; not maintaining the salon in a safe, orderly and sanitary condition by allowing the hot wax bowl top and sides to be covered with old wax; not having clean towels stored in a closed container; and operating an unlicensed cosmetology salon within the square footage of the cosmetology school. Wendy Tran Le, d/b/a Beauty Nail Salon, license no. CY104426L of Philadelphia, Philadelphia County, was ordered to pay a civil penalty of \$500 because it practiced nail technology in a grossly incompetent or unethical manner through the use of metal razor tools. (03/07/11)

Charlene Mills, license no. CT010802L of Philadelphia, Philadelphia County, was ordered to pay a civil penalty of \$500 because she practiced as a cosmetology teacher while not currently licensed and registered. (03/07/11)

Jinette Anderson and Domingo Vargas, individually, d/b/a Jinette's Dominican Hair Salon and Jinette's Dominican Hair Salon, license nos. CB121949 and CO251977 of Philadelphia, Philadelphia County, were ordered to pay a civil penalty of \$2,200 and costs of investigation of \$27.29 because they failed to designate a person in charge in the absence of the owners; failed to display in a conspicuous place in their principal office, place of business, or employment, licenses granted by the board; and employed three unlicensed employees, with each unlicensed employee being a separate violation. El Rey Beauty Salon Inc., d/b/a El Rey Mixteco Salon, license no. CB120907 of Philadelphia, Philadelphia County, was ordered to pay a civil penalty of \$4,000 and costs of investigation of \$58.60 because it employed unlicensed employees and aided and abetted the unlicensed practice of cosmetology. ## **Washington County**

Sally E. Jenkins, license no. CQ000816L of Canonsburg, Washington County, was ordered to pay a civil penalty of \$1,500 because she practiced as an esthetician when she was not currently licensed and operated a salon that was not licensed or registered. (03/07/11)
