CA047485, of Reading, Berks County, had a public reprimand placed on her permanent Board record and was ordered to pay a civil penalty in the amount of \$1,000 because she practiced as a certified public accountant when she was not currently licensed and registered. Bucks County

Alexander A. Cicchitti, license no. C030458L, of Warminster, Bucks County, was ordered to pay a civil penalty in the amount of \$600 and, within six months of the effective date of the order, complete three hours of continuing professional education in tax subjects because he failed to complete at least eight credit hours of continuing education in tax subjects during the January 1, 2008 to December 31, 2009 renewal period and also failed to provide documentation in response to a notice of audit of the Board. abbreviation tending to indicate that the person is a public accountant without being registered as a public accountant and a licensee or without receiving or being notified in writing by the board that it has qualified to receive a certificate as certified public accountant issued by this Commonwealth. CA006255R, of Radnor, Delaware County, has immediately, permanently, and voluntarily surrendered his license and certificate to practice as a certified public accountant in the Commonwealth of Pennsylvania because his right to practice before a federal or state government agency was suspended or revoked.
