## **Bureau of Charitable Organizations**

### **Out of State**

On April 26, 2012, the Secretary of the Commonwealth issued an adjudication and order assessing an administrative fine in the amount of \$5,000 against Advantage Fund-Raising Consulting, Inc. for violations of the Solicitation of Funds for Charitable Purposes Act ("Act"). Advantage Fund Raising Consulting, Inc. solicited charitable contributions in Pennsylvania without being properly registered with the Bureau of Charitable Organizations and in violation of a cease and desist order. Respondent also

failed to file contracts with the Bureau prior to rendering professional solicitor services. Advantage Fund Raising Consulting, Inc. is located in Las Vegas, Nevada.

Thumbs-Up Telemarketing, Inc., of St. Louis, MO, was assessed an administrative fine of \$1,000 for violations of the Solicitation of Funds for Charitable Purposes Act (Act) which include failing to pay an administrative fine assessed to Respondent for providing professional solicitor services without being registered with the Bureau of Charitable Organizations (Bureau) and soliciting in violation of a cease and desist order. Thumbs-Up Telemarketing, Inc. was ordered to cease and desist from all manner of solicitation activities in the Commonwealth, until such time as all information requested by the Bureau has been provided, all penalties imposed have been paid in full and Thumbs-Up Telemarketing, Inc. comes into full compliance with all provisions of the Act, including proper registration. Thumbs-Up Telemarketing, Inc. is prohibited from renewing its registration as a professional solicitor in Pennsylvania unless and until all administrative fines are paid.
